Any disputed matters shall be resolved in arbitration by the American Chamber of Commerce, Chattanooga, TN. in accordance with statutes of the Chamber. Decision by the Chamber of Commerce will be final and binding. All parties consent to jurisdiction in Chattanooga Tennessee only. Platinum Entertainment will arrive and perform in proper attire. Platinum Entertainment Dj's will not consume any form of alcoholic beverages or illegal substances while at event. The venue must provide a table for Platinum Entertainment. If cancellation occurs within 1 month prior to event; client will forfeit entire balance to Platinum Entertainment as liquidated damages. If the location and or date of venue are changed, Platinum Entertainment reserves the right to adjust contract/price as necessary. Platinum Entertainment will arrive on time and prepared for event. Platinum Entertainment is not responsible for any natural disasters, traffic, any actions by guests at the event or other circumstances outside of Platinum Entertainment's reasonable control, before or during the event, which could lead to the disruption or complete halt to the event. Client cannot make changes to Planning forms, Event Timelines, or Music Request lists, within 2 weeks of event without first contacting Platinum Entertainment. Client MUST provide a meal for DJ equal to the guests' meal. A \$50.00 charge will be added to event if meal is not provided as described. This contract contains the entire agreement of the parties with respect to the subject matter of this contract, and supersedes all prior negotiations, agreements and understandings with respect thereto. Changes may be made only with Platinum Entertainment's written consent. A \$50.00 late fee will be applied if final payment is received after the due date 30 days before event.
