In reviewing the attendance records for the Natural Event Mitigation Advisory Committee meetings, it has come to my attention that you are in violation of City Code Section 2-307, which requires all members of Council appointed boards, commissions, committees, authorities or other similar agencies to attend 75 percent of the regularly scheduled meetings in a calendar year. The attendance issue raises particular concern because it becomes difficult for boards and commissions to successfully conduct business due to member non-attendance.

Serving on the City's boards, commissions, committees and authorities is a wonderful way to serve the community in which people live, work and raise families. It provides a way to share knowledge, wisdom, expertise and services that are of intrinsic value to the City. As a valued member of the Natural Event Mitigation Advisory Committee, your presence at the regular meetings is very important.

A written response advising of your planned participation with the Natural Event Mitigation Advisory Committee or a copy of your resignation should be sent to my attention no later than April 10, 2015. If we do not hear from you by this date, we will consider this letter your statement of resignation.
