1. Assignment of rights

4.1. No verbal agreement will be relevant or allowed to modify or add to this agreement. Any changes, amendments or collateral agreements will have legal effect only if (i) in writing, and (ii) executed by entrant and assignor.

5. Assignor and entrant each individually warrant that it is free to enter into and fully perform this agreement.

6. Governing law

6.1. This agreement will be governed by the laws of the commonwealth of Massachusetts applicable to agreements made in and wholly to be performed in this state, and the parties submit and consent to the jurisdiction of the courts of the state in any action brought to enforce (or otherwise relating to) this agreement.
