Wedding policy:

The Gleaner's deadline for submitting weddings is NOON on Tuesday prior to the Sunday of publication. We publish wedding announcements one time and once a week in the Sunday Features section. There is no charge for this service, but there are some rules that apply to publication:

Wedding accounts should appear in the newspaper within 12 weeks following the wedding.

Forms outlining the information that can be used in the announcement are available at the newspaper office at 455 Klutey Park Plaza, or forms can be mailed, faxed or emailed to you.

The announcement can include a photograph of the bride or of the couple. A black-and-white photograph is best for reproduction. A color photo can be used, but it should be a professional-quality photo rather than a snapshot. We do not accept computer print-outs. Please tell your photographer about the 12-week deadline.

The Gleaner will not publish your wedding announcement in the Sunday edition immediately following a Friday or Saturday wedding.

A phone number should be included in case there are questions.

After publication, photos may be picked up at The Gleaner business office or can be returned by mail if a self-addressed stamped envelope is provided.
