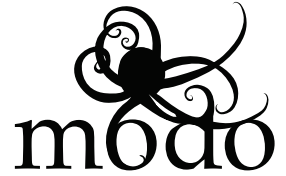

Consignment Contract: I ("the Consignor") have read Modo Boutique's Consignment Contract. I understand that by signing this Consignment Contract I am agreeing to all of the *Terms and Conditions* outlined below.

Terms and Conditions: I hereby consign to Modo Boutique the described item(s) which Modo Boutique, as agent, will offer for sale online and in the Modo Boutique storefront. For its services, Modo Boutique will receive and retain, from the proceeds of the sale, commission from the Consignor based on the provided table. The commission fees charged by Modo Boutique include coverage of all eBay & paypal fees. Modo Boutique will pay the Consignor the net proceeds received and collected from the sale of the property after receiving payment from and deducting its commissions.

Modo Boutique in its sole discretion may cancel the Consignment Contract and return the property to the Consignor. The Modo Boutique accepts returns of items sold online and in-store from customers who are not satisfied with their purchase for any reason. The Consignor accounts will be debited for all returns accepted under the Modo Boutique's return policy. The Consignor agrees to pay any balance for returns that may be charged to their account. By agreeing to the Terms and Conditions, signing the Consignment Contract and placing the items for sale at the Modo Boutique, I guarantee that all items consigned to the Modo Boutique for sale are lawfully and entirely owned by me or I am acting on behalf of a person(s) who have given me the authority to sell such items on their behalf. I guarantee to indemnify Modo Boutique for any damages, penalties, fines, fees or judgments for any issue arising due to the rights of the lawful owner of the merchandise being placed on consignment. Only original, authentic designer items are accepted by the Modo Boutique for consignment. By submitting items for consignment, the consignor states that the items are authentic designer items and not counterfeit or "knock-offs".

Modo Boutique does not provide any type of insurance or guarantee to consignors for items placed on consignment that covers any loss or damage to the Consignors property while in its possession. Modo Boutique will take diligent care of the consigned pieces as to the best of its ability. Modo Boutique does not cover losses to consigned property for theft or damages. This includes any damage caused by a customer, fire, flood, earthquakes, stains, tears, missing pieces, damage caused during shipping, or any other damage with no exclusions of man-made or natural damages to consigned items. By leaving items on consignment I release Modo Boutique against and loss or damage to my item while in possession of Modo Boutique.
