The Student and I acknowledge that the Student submitted the Art to the Contest for the use of Arlington County. On behalf of myself and the Student, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I hereby grant to Arlington County a perpetual, royalty-free, nonrevocable license to use, license, and incorporate the Art, and any portions or images contained therein, in whole or in part as the County sees fit and appropriate in any manner and in all media, in any and all versions, whether now known or hereafter devised, in any and all languages throughout the universe and in perpetuity. Arlington County has the right to change, edit, alter or modify the Art in any manner. If the Art is chosen for further display, use or promotion, Arlington County may publicize the Student as the artist, but I understand that Arlington County cannot accord us credit in all circumstances. All Art submitted will become the property of Arlington County, and Arlington County, on receipt of this Release shall become the sole and rightful owner of any and all material included in the Art. I understand that submissions, including the Art, will not be returned, and that Arlington County reserves the right to destroy all submissions. Arlington County is not responsible for lost, damaged or misdirected submissions at any time.

If the Student is a contest winner and/or if my Student's Art is chosen for further display, I further transfer all of my rights in the Art, including without limitation all copyright and intellectual property rights, to Arlington County, and I further grant to Arlington County the absolute and irrevocable right and permission to photograph, film, videotape, record and/or portray the Student's name, voice, portrayal, actions and/or likeness in connection with the Contest and other uses Arlington County may make of the Art, and to use the results and proceeds thereof as follows: (a) to copyright the Art in Arlington County's own name or in any other name (the Art shall be considered a "work made for hire"); (b) to use, incorporate, broadcast, distribute, re-use, publish, re-publish, alter and/or edit the Art and/or the Student's name, likeness and portrayal in whole or in part, severally or in conjunction with other material for any purpose and in any manner whatsoever as Arlington County so chooses in any and all media, now known or hereafter devised, in any and all versions, throughout the universe and in perpetuity, as well as for promotion, merchandising, publicity and advertising. Arlington County has no obligation to use the Art or the Student's name, voice or likeness.

I represent that I have the right and authority to grant to Arlington County the rights granted herein, including without limitation the right to use the Art without the necessity of making payments to or obtaining the consent of any third person or entity. I represent that the Art does not infringe upon the rights, including but not limited to any intellectual property rights, of any third party or entity. I further represent that this release does not in any way conflict with any existing commitment on my part, nor will I enter into any agreement in the future that conflicts with or in any way limits the rights I have granted herein.
