This is a Contract between Umbrella Pet Services and the pet owner whose signature appears above.

1. Owner agrees to pay the rate for day care and/or boarding in effect on the date the pet is checked into Umbrella Pet Services facility.
2. Owner further agrees to pay all charges for special services requested and all veterinary costs for pet during the time said pet is in the care of Umbrella Pet Services facility.
3. Owner assumes any expense or liability for injuries that owner's pet may inflict upon any human, other pet or itself (owner's pet) while in the Umbrella Pet Services facility.
4. Owner further agrees that the pet shall not leave the facility until all charges are paid to Umbrella Pet Services.
5. By signing this contract and leaving said pet with Umbrella Pet Services, owner certifies to the accuracy of all information given about said pet on first page of Registration and Release form (Contract).
6. Umbrella Pet Services shall exercise reasonable care for the pet delivered by the owner to the facility for boarding, grooming, bathing or day care. It is expressly agreed the owner and Umbrella Pet Services that facility's liability shall in no event exceed the current chattel value of a pet of the same species of the pet boarded. The owner further agrees to be solely responsible for any and all acts of behaviour of said pet while it is in the care of Umbrella Pet Services.
7. Owner specifically represents that s/he is the sole owner of the pet, free and clear of all liens and encumbrances.
8. Owner specifically represents to Umbrella Pet Services that the pet has not been exposed to rabies or distemper within a thirty-day period prior to being left for boarding or day care.
9. All charges incurred by owner shall be payable upon pick-up of pet, or when billed by Umbrella Pet Services at address listed on contract. Umbrella Pet Services shall have and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding, day care or any other service provided by Umbrella Pet Services.
10. If pet becomes ill or if the state of the pet's health otherwise requires professional attention, Umbrella Pet Services, in its sole discretion may engage the services of a veterinarian, administer medicine or give other requisite attention to the pet and the expenses thereof shall be paid by the owner. Owner gives consent to Umbrella Pet Services to act in the owner's behalf in obtaining emergency veterinary care at owner's expense if deemed necessary by Umbrella Pet Services or any of its employees. Owner indemnifies and holds Umbrella Pet Services and its employees harmless for said expenses.
11. Owner assumes full responsibility for any injury, illness or effects while in the care of Umbrella Pet Services.
12. The contract contains the entire agreement between the parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives and assigns of the owner and Umbrella Pet Services.
