

## TERMS OF RENTAL AGREEMENT

This is an agreement between the hirer (You), and Cairns Scooter World (the Company identified on the RENTAL AGREEMENT), to rent a scooter as described in the RENTAL AGREEMENT.

1. You agree that the scooter is delivered to you in good operating condition. You agree to return the scooter in the same condition (except fair wear and tear), complete with tools, helmets and keys, and to the same location (47 Shields St, CAIRNS), at or before the time and date due BACK, or sooner if demanded by the Company. The Company may take possession of the scooter at any time should it be suspected that the scooter has been used in breach in any way, of this rental agreement, or has been illegally parked, or has been involved in a traffic violation, or has been used for an illegal purpose. Should You wish to extend the period of rental, You must seek authority of the company and the company must agree. If the scooter is not returned at or before the back time, the scooter will be reported to Police as being stolen.
2. Only the hirer and/or the authorised driver as identified in the RENTAL AGRFEEMENT are to operate this scooter. You must operate the scooter within traffic rules and regulations, and in a manner which is safe. It must not be operated by a hirer who is under the influence of drugs, or whose blood alcohol level is above the legal limit. It must not be operated by a driver whose licence has been revoked or suspended, or who has tendered false identification. It must never be operated off sealed roads or sealed surfaces.
3. The Company will not refund a deposit, nor will a hirer demand return of a deposit, in the event of a breach of any of the terms of a Rental Agreement.
4. The hirer of the scooter is responsible for any loss of, or damage to, the scooter and its tools (if provided) and helmets during the period of the rental. Deposit will be withheld until repairs are complete and after costs have been deducted, including down time at the normal daily rental rate for the period of downtime, any balance will be refunded, or in the case of extensive damage or loss, the Company is authorised to recover the total cost of repair/replacement of the scooter and helmets up to the value as defined in the Rental Agreement, from the credit card nominated in the Rental Agreement. Where the scooter is returned as rented, and no terms are breached, deposits will be refunded in the same manner as paid, less an amount for fuel at \$5.00 ltr, if the scooter is not refuelled.
5. The hirer is responsible to inspect the scooter prior to departure from the rental location, for damage, and to notify the Company immediately any damage is sustained by the scooter. The hirer will also notify the Police should it be involved in a traffic accident and follow instructions from the Police. In the event of a Third Party Property insurance claim, the hirers deposit becomes the excess payable.
6. The hirer totally indemnifys the company of any responsibility in relation to this rental, loss of personal property, or any other matter occurring during or as a result of this Rental Agreement.
7. The scooter is rented full of fuel and oil, and it is the renters responsibility to refuel the scooter immediately prior to its return.
8. Breakdown callout fee of \$100.00 applies for out of fuel in Cairns area, \$150.00 north of Ellis Beach or west of Smithfield or south of Edmonton.
9. The Company is bound by Privacy Laws, and will not disclose any of the hirers or authorised drivers details to any one other than law enforcement agencies.
