The non-refundable deposit of \$900 is payable at anytime to reserve your wedding date. The complete balance (final payment and any additional costs listed and/or selected above) is due within one week of your wedding date and before the finished product is delivered.

In the event that more than one client wishes to book wedding services on the same day, preference will go to the first client to pay the deposit. Rescheduled weddings will only be accommodated if the new date does not conflict with another booked wedding.

Media Parable LLC will be the exclusive professional videographer. Friends and family are permitted to operate video cameras on the condition that they do not interfere with or get in the way of the professional coverage. It is the client's responsibility to secure access to areas for videography. Media Parable LLC will not be responsible for coverage lost due to access restrictions.

Creative aspects such as shooting and editing style are at the discretion of Media Parable LLC.

Media Parable LLC will not be held liable for any production problems beyond our control, e.g. bad weather, accidents, poor acoustics/lighting, interference from guests, etc.

Media Parable LLC reserves the right to terminate this contract at any time for any reasonable cause, e.g. accident or ill health, or other unforeseen circumstance. In this event ALL monies paid will be refunded in FULL.

Any liability on the part of Media Parable LLC will be limited to the amount of monies paid.

Copyright will be owned by Media Parable LLC. Further editing of any assets created by Media Parable LLC is prohibited unless written permission has been granted.
