For the safety of all parties participating in services at Sew & Design Studio, please read the terms detailed below, and complete all fields below and provide a signature confirming your understanding and agreement to all terms herein.

- 1. Students/customers under the age of 18 must have a parent or legal guardian complete any required registration documents and this liability release form before the student or customer will be allowed to participate in activities on the premises.**
- 2. Participation in the use of any of the equipment on the premises is solely at the risk and liability of the student/customer (or parent/legal guardian if under the age of 18).**
- 3. As stated above, every effort will be made by Sew & Design Studio and its agents to ensure safe use of all equipment by students/customers, but due to the potentially dangerous nature of sewing equipment and tools, Sew & Design Studio will not accept liability for any injury or damages that the students or customers may suffer related to the premises of Sew & Design Studio, or activities sponsored by Sew & Design Studio.**
- 4. In the case of injury, any cost incurred from the emergency medical treatment or medical transportation to a local hospital will solely be the responsibility of the student/customer (or parent/legal guardian if under the age of 18).**
- 5. Any personal belongings of the student/customer or the legal guardian that enter the premises of Sew & Design Studio remain the sole responsibility of the student/customer or legal guardian. Sew & Design Studio shall not be responsible for lost, stolen, or damaged property or belongings.**
