The right to use the Photographs or any derivation thereof may be granted, transferred or assigned by the Photographer to any third party subject to the terms and conditions of this release.

I confirm that my participation and appearance in the Photographs are voluntary and free of charge or, if for a fee, that all fees have been paid in full to me and there shall be no other payment or royalty due to me in respect of the Photographs and any derivation thereof.
