

RHETORIC Event Vendor Contract

The parties to this contract are The Passion For Christ Movement (hereafter "Host") and _____ (hereafter "Vendor").

Whereas, Host is hosting an Event known as Rhetoric 2015 to occur at Cottonwood Church on 08/07/2014, beginning at 07:00 pm.

Now, therefore, the parties agree as follows:

1. Vendor shall have access to the location agreed upon by the parties no less than 1/2 hour before the Event's commencement for the purpose of setting up Vendor's vending station, goods, and other things necessary and reasonable to vending at the location. Vendors shall check in with P4CM Vendor Manager no later than 5:00 pm on Event day or risk losing spot.
2. Vendor shall not vend or display any goods or services other than those described herein at and during the Event without the Host's written consent.
3. Vendor's staff may announce the availability of the goods to be vended only while they are within the confines of the vendor's location.
4. Vendor will choose their location on a first come first serve sign up that will be sent to them by the P4CM Vendor Manager prior to the show. The Vendor Manager will give a prior notice of when the sign up will be available, so that each Vendor has an equal chance at first come.

5. Vendor's staff shall be clothed and groomed in a clean, neat fashion and shall conduct themselves in an orderly fashion.
6. No loud music, noise, or sound amplification devices shall be used by Vendor on location.
7. Vendor must be packed and out of the parking lot by midnight after the show. Vendor must dismantle and remove all things brought to the location. Vendor shall leave the location clean of trash and substantially in the condition it was before Vendor occupied it. Failure to do so will result in a \$50 fine.

8. All selling and promotion MUST take place at your designated table. Please set-up your table in a presentable fashion. Your table must be approved by the P4CM Vendor Manager prior to check in time.
9. Vendor warrants ownership of or has acquired necessary licenses for all products on sale or display.
10. Nonrefundable deposit due by July 6, 2015 or date of signed agreement, whichever is later. Fee must be paid in full by July 17, 2015 or date of signed agreement, whichever is later. If either deadline is missed without written approval, you risk losing your slot.
11. This Package includes four tickets inside the auditorium, selling and/or promoting you or your organization via brochures, flyers, posters, banners, magazines, wristbands, CD's, DVD's, books, and apparel (e.g. clothing and hats, jewelry), as well as setting-up your table with banners and posters, etc. Custom refreshments (e.g. drinks, desserts, light snacks, etc.) must be approved. Package includes a free giveaway item of yours during the show, plus a still photo promo of your logo on the screens during the show, promotion on p4cm.com and the Rhetoric smartphone app plus a brief promotional audio or video clip of your choice no more than 60 seconds. You must submit a high-resolution logo and/or video that you produce no later than July 24, 2015.

12. To gain access to the auditorium where RHETORIC will be held, Vendor staff member must have a ticket to the show. All tickets to the show will be given to the vendor main point of contact to distribute. Tickets for additional staff members beyond what is included in the vendor package can be purchased on the website at regular price. There is a maximum of 5 people at a time allowed to work at each booth.

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

FOR RHETORIC by Passion for Christ Movement, Inc. (P4CM)

I am a duly authorized representative of the aforementioned company and agree to follow all Event terms, guidelines, safety, security and health regulations, and all applicable local, state, and Federal laws and regulations. It is strongly recommended that Vendor carry their own insurance policy to cover their actions and to comply with any applicable insurance requirement of the Los Angeles County Health Department. By participating in RHETORIC, Vendor agrees to indemnify, waive any claim against, and agree to hold harmless Passion for Christ Movement, Inc., their employees, volunteers, assignees, other participants, any sponsor, owner or lessors of premises from all claims losses, costs, damages or expenses resulting or arising from any and all injuries to or death of any person or damage to any property caused by an act, omission, or neglect of Vendor's agents, employees, invitees, contractors, or guest which occur in or about the Event.

If any clause or section of this Agreement shall be found to be invalid, illegal, unenforceable or in conflict with the law of any jurisdiction, the validity, legality and enforceability of the remaining clauses or sections of this Agreement shall not in any way be affected or impaired.

IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
