Mann Island Finance Limited is a credit broker, which is part of the Investec group of companies and which arranges finance, predominantly in the automotive sector, for both retail and business customers. We can introduce you to a number of lenders who may be able to finance your purchase. We can only introduce you to these lenders. One of these lenders is MI Vehicle Finance Limited, a linked company, also part of the Investec group of companies.

In order to consider your application for finance, we will ask you to provide financial and other personal information about yourself (your "Personal Data"). Your Personal Data is protected under the Data Protection Act 1998. The following notice summarises some key information about how we process your Personal Data. If you would like a more detailed explanation of how we will manage your information and your rights to access the information we hold about you, please refer to our Investec Group Data Protection Statement (the online Data Protection Statement), which can be found at [www.investec.co.uk/dataprotection](http://www.investec.co.uk/dataprotection).

By making an application for finance through us, you agree that we can use and disclose your Personal Data in the ways described in this notice. We will always process your Personal Data in accordance with the requirements of the Data Protection Act 1998 and any related legislation, as amended from time to time.

### Transmission of your Personal Data

Where you provide your Personal Data to a dealership for the purpose of applying for credit through us, it will be recorded by the dealership and may be transmitted to us through the internet. While we and the dealership will take all reasonable security precautions to protect your Personal Data, the nature of communication on the internet is such that we cannot guarantee its security. Any transmission is therefore at your own risk but once we have received your information, we will use strict procedures and security features to prevent unauthorised access.

### Sharing your Personal Data

Your Personal Data will be used by us to process your application and we may disclose it to other Investec Group Companies as part of that process, including MI Vehicle Finance Limited. We and other Investec Group Companies may also process your Personal Data for credit-checking or fraud-prevention purposes in the future and may also share it with fraud prevention and credit reference agencies (see below for further details about this). Other than in relation to marketing (in respect of which we will ask you to indicate your preferences separately only if you decide to proceed with finance arranged through us), we will process your Personal Data in the ways described in the online Data Protection Statement, as amended from time to time.

We will also share your information with lenders in order to obtain quotes and to process finance applications through them.

### Credit Assessment

When assessing your application for finance, we may use a credit-scoring or other automated decision-making system. We may also look at records that we or other Investec Group Companies hold about you. In addition, we may look at records held with credit reference agencies (CRAs). CRAs can give us public information (e.g. data on the electoral register), as well as non-public credit information shared between organisations. When CRAs receive a search from us, they will place a 'footprint' on your credit file, but this can only be seen by you and not by other organisations (eg, lenders) accessing the CRA data.

Lenders to which we have passed your Personal Data for the purpose of arranging finance may also conduct searches of your record held with one or more CRAs.
