This contract (hereinafter referred to as "Contract") for the Sales of Automobiles is made between Sales representative J.Jainaguli (hereinafter referred to as "Seller") representing "Khangai Service" LLC, Address: Nalaikh District, 1st khoroo, Uurhaichdiin 1-A, Ulaanbaatar and Procurement Specialist Ch.Batzorig, representing Darkhan Wastewater Management Project (hereinafter referred to as "Buyer") Address: Chingeltei District, 4th khoroo, 51-6-601, Ulaanbaatar and together referred to as "the Parties", based on the Articles 243-264 of the Civil Law of Mongolia.


1. GENERAL

- 1.1 By this agreement, the Seller has the responsibility to deliver the Buyer an automobile with standards, technical specifications, and color stated in the contract, and the Buyer has the responsibility to receive the automobile and make the payments stated in the contract.
- 1.2 The Parties are entitled to an equal right in the contract, and thoroughly reviewed and accepted each subject of this contract.
- 1.3 The Contract will have the following appendix and the appendix will be an essential part of the contract.
 - The Appendix 1 will include standards, additional equipment, technical specifications and the color.
 - The Appendix 2 will include Warranty.
- 1.4 The ownership of the automobile will be passed to the Buyer once the payment is fully made.

2. PRICE OF THE AUTOMOBILE AND PAYMENT TERMS

- 2.1 The government project automobile will have the following price: 130,000,000.00 MNT (one hundred thirty million). This price exclude VAT and purchase will be made from ADB loan.

2.2 The Buyer will have the responsibility to make the payment to the Seller on the contract date.

2.3 The payment will be considered made only when the Buyer transfers the full amount to the Seller's bank account and presents the proving document to the Seller, or pays the Seller in cash.

3. RIGHTS AND RESPONSIBILITIES OF THE PARTIES

3.1 The Buyer's Rights and Responsibilities:

3.1.2 To demand the Seller to deliver an automobile with the standards, additional equipment, technical specifications and the color on an agreed date.

3.1.3 To demand the Seller to comply with the responsibilities set forth in this contract.

3.1.4 To demand the Seller to provide true and accurate information about the quality and specifications of the automobile.

3.1.5 To refuse to receive an automobile different from the one that is described in the Appendix 1.

3.1.6 To check if the specifications of the automobile matches the actual order, and ask the Seller to issue a Note of Deliverance.

3.1.7 To be fully responsible for the wellbeing of the automobile after receiving the automobile with the Note of Deliverance.

3.1.8 To take proper care of the vehicle, and respect the intended usage of the vehicle during the warranty period.

3.1.9 To be responsible for all related costs including the issuance of number plate, registration, inspection, and insurance.

3.1.10 To be fully responsible for any matters related to ownership of the vehicle after the vehicle is officially transferred to the buyer.

3.2. The Seller's Rights and Responsibilities:

3.2.1 To demand the Buyer to comply with the responsibilities set forth in this contract.

3.2.2 To deliver an automobile to the Buyer with standards, additional equipment, technical specifications and the color described in the Appendix 1 with no apparent and legal defect.

3.2.3 To be not responsible for the non-manufacturing defect and accident or disappearance of the automobile after the Delivery date to the Buyer.

3.2.4 To pass the ownership of the automobile to the Buyer once the payment is fully made, and to deliver the related documents as well.

4. DELIVERY OF THE AUTOMOBILE, WARRANTY PERIOD

- 5.2. If the Parties are not able to execute their responsibilities due to sudden or force majeure which resulted damage to the automobile, the Seller will bear the risk before the ownership is passed to the Buyer, and the Buyer will bear the risk after the ownership is passed to the Buyer.

6. OTHER





Manufacturer's warranty

The warranty includes the repair or replacement of any parts that are defective in material or workmanship provided by the Supplier. The Warranty is only applicable in the country it was sold. Warranty is void if the service was not done according to Warranty Service as shown in attachment 1.

Factors beyond the suppliers control are not covered under warranty. Such as: Repairs and adjustments required as a result of misuse (e.g., racing, overloading), negligence, modification, electrical wiring modification, alteration, tampering, disconnection, improper adjustments or repairs accident and use of add-on parts/ material are not covered. Cosmetic or surface corrosion from stone chips or scratches in the paint is not covered by the warranty. Repairs and adjustments caused by improper maintenance, lack of required maintenance, or the use of low grade, unsatisfactory (oil, lubricants, diesel and gasoline fuel) fluids other than the fluids specified in Owner's Manual. 
