## PURCHASER AND THE VENDOR HEREBY AGREE AS FOLLOWS:

- 1 In consideration of the Reservation Fee the Vendor hereby reserves the Apartment specified in this agreement for sale to the Purchaser until the end of the Reservation Period (7 days from the signing of this form).
- 2 I/We acknowledge that I/we am/are not entitled to any interest which accrues on the Holding Deposit which is held in trust.
- 3 At any time prior to the signing of a Contract of Sale for the Apartment by the Purchaser, the Purchaser may end this Agreement in which case the Reservation Fee shall be refunded to the Purchaser (less applicable administration fee).
- 4 When the Purchaser executes a Contract of Sale for the Apartment the Reservation Fee shall be applied towards the deposit payable under that contract.
- 5 If the Purchaser does not execute a Contract of Sale for the Apartment reserved under this reservation in a form acceptable by the Vendor by the end of the Reservation Period and pay the balance of the deposit of 10% of the price of the Apartment or provide a bank guarantee as security for the balance of the deposit of 10% of the price as required under the Contract of Sale, any rights of the Purchaser under this Agreement will lapse and the Reservation Fee will be refunded (less applicable administration fee).
- 6 I/We acknowledge that:
  - The Vendor has no obligation to agree to sell an Apartment in the Development, to me/us, and may refund the Holding Deposit to me/us in its sole discretion and at any time without being required to justify or explain such action;
