- Work of rewinding will be done with Atlas-Brand S.E. Copper wire.
- Bearings of brands NBC or SKF shall be used if needed to change in fan/motor.
- Bush, shaft, condenser and clutch-governor etc of standard Brand shall be used, if needed to change in fan/motor.
- The replaced unserviceable/dismantled materials of fans & motor like burnt- S.E. wire, bearing, bush, shaft, condenser, clutch & governor etc. shall be property of the Institute. These should be returned to I/c Electric Section along with the repaired items.

6. The rewinding work/job of the item shall be completed within 30 days from the date of issue of order, failing which the liquidation @ 0.5% per week of work order shall be imposed.
7. The rates covered for above work/items shall be for a period of one year under this rate contract. To execute the repairs under this contract, the firm shall not be entitled to any increase in price and cost whatsoever, on any ground. However, the purchaser shall be entitled to the benefit of any decrease in price and cost on any ground, whatsoever, of the goods & services, executed during the period of one year.
8. Service tax registration number is required as per Rules in force applicable.
9. Director, CARI, Izatnagar reserves the right to reject or accept any tender or all tenders at any times without assigning any reasons.
