MODEL RELEASE: The CLIENT hereby grants to Nicholas Gore and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of the CLIENT or in which the CLIENT may be included for the Photographers Portfolio, samples, self-promotions, Photographer's web pages, entry in photographic contests or art exhibitions, editorial use, advertising, web pages or for display within or on the outside of the Photographer's studio, to alter the same without restrictions and to copyright the same. If the Photographer desires to make other uses, the Photographer shall not do so without first obtaining written permission of the Client.

IMAGE USE: The CLIENT will receive the full resolution files of all final images from their event. The CLIENT will also receive full print rights to these images. The CLIENT agrees that in the event of the images use on social media the CLIENT will add a link to www.CharlestonsWeddingPhotographer.com/Blog in the description of all files, including but not limited to profile pictures and photos submitted by mobile devices.

LIMIT OF LIABILITY: In the unlikely event that the photographer is injured or becomes too ill to photograph the event, Nicholas Gore will make every effort to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. Nicholas Gore takes the utmost care with respect to exposure, transportation, and processing the photographs; however, in the unlikely event that photographs have been lost, stolen, or destroyed for reasons within or beyond Nicholas Gore's control, Nicholas Gore's liability is limited to the return of all payments received for the event package. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals.

ADDENDUM TO EVENT CONTRACT: Should the Client request to postpone the contracted event, the Client and Nicholas Gore will mutually agree on a new date for the event. The Client must advise Nicholas Gore of postponement no less than 2 weeks (14 days) from the original contracted date. The new wedding date must be within 12 months of the first wedding date. No financial penalty will be required from the Client for postponement but the full amount of the wedding photography will still be owed at least 2 weeks before the original wedding date. If, however, the event is cancelled, the cancellation policy outlined below will go into effect.

SECURITY RETAINER: In the event of cancellation, the security retainer paid is non-refundable. It shall be liquidated damages to Nicholas Gore in the event of a breach of contract by the CLIENT. The CLIENT shall also be responsible for payment for any Nicholas Gore's material charges incurred up to time of cancellation. If the event is cancelled within 9 months of the event date, 50% of the full wedding photography cost must be paid as a penalty for reserving the date. If the event is cancelled within 1 month of the event date, 75% of the full wedding photography cost must be paid as a penalty for reserving the date.

RECEPTION: If CLIENT has booked Nicholas Gore for more than 6 hours, a meal, and break of at minimum 15 minutes to eat will be required for both Nicholas Gore and any assistants. It is the CLIENT'S responsibility to inform Nicholas Gore of an appropriate time, and while Nicholas Gore will make all efforts to avoid missing any important images throughout the night, Nicholas Gore is not liable for any missed images during this break.

COMPLETION SCHEDULE: Online image galleries will take up to two weeks to create. Albums may take over a month to create.

PAYMENT SCHEDULE: ____ due at the signing of this agreement. Balance payable in full at least 2 weeks before the wedding.

THE PHOTO BOOTH: If "The Photo Booth" is available at the wedding/party, the CLIENT is responsible for any and all damage to equipment caused by themselves or their guests. If any part of "The Photo Booth" is broken during its use by the CLIENT or the guests of the CLIENT, the CLIENT will not be refunded for the time lost and the CLIENT will be responsible for replacing the equipment. All wedding/party images (not just "The Photo Booth" images) will be held until all broken equipment is completely paid for.
