SCHEDULE “A”

Sub: - Job work for supply & replacement of Self pulsating air header of APU in GT #1 at Gas Based Power Station - UTRAN(Web.18/12/MMD-I)

Scope of work.

1. The Job involves to supply of Schedule 40 M.S. pipe of 6” in diameter seamless as per IS standard to working site at Gas Turbine area .
2. The job involves Supply 6” dia size schedule 40 seamless pipe /Header two no each pipe for fitment along with necessary gasket & nut/ bolt/washer / jointing material.
3. The job involves pre preparation at site prior commencement of work.
4. The job involves arrangements of special tool tackles for the job at site.
5. The job involves arrangement of Welding rod & Cutting gas along with welding machine & cutting set.
6. The Job involves complete transportation man power at site at his cost. No separate transportation cost shall be payable.
7. The work involves to upkeep the issued material in his safe custody & party shall be responsible for any theft etc.
8. The job involves dismantling & removing existing pipe/header from it’s position ,fabrication of new header with cutting &welding as per existing header (as per Drg) ,welding nipples for SOLENOID valve connection as per existing position & fitting of Headers in it’s position .Drg. dimensions are tentative and new headers will be fabricated to match with old dismantled header dimension & both headers will be completely inter changeable.
9. The Job work involves complete coating with non corrosive paint (red oxide) + epoxy paint of standard make grey shed as per standard procedure to complete header & nipple
- 10.The job work involves credit of cut scrape (if any) to main store. All scrap will be GSCEL property & credited to main store.
- 11.The contractor will have to bring all the consumables like gas, welding rod, Red oxide, brush, nut bolt etc at his own cost.
- 12.All the necessary Testing like Leak-Test for the welded pipe are to be conducted by the contractor at a pressure of 02 Kg/cm². If during testing, any re-weld is to be

done, it has to be carried out by the contractor free of cost till the satisfactory testing is done

13. The contractor will have to give at least one year PERFORMANCE GUARANTEE for the header pipe work as well as joints done.
14. Electrical connection & water connection shall be supplied, FREE OF COST by the GSECL
15. No Extra charges will be paid by the GSECL for Loading, Unloading & carting of the materials as rates are all inclusive.
16. For any dispute, the decision of the I/c Chief Engineer shall be final and binding to the contractor.
17. The work will have to be completed within 20 days.. However contractor will have to start the work immediately on getting intimation from GSECL.
18. Payment will be made as per Actual Work done by the contractor, and as per GSECL terms and conditions.
19. VAT, other Govt. taxes etc will be born by the contractor.
20. The contractor has to observe all the safety rules for the safety of himself, his labours, Plants etc.

1. Evidence of having successfully carried out job work of supply & erecting headers /pipe & commissioning above in any power station/heavy industry/project/Reputed organization successfully. The work order copy for the same must be furnished by the party.
2. Bank Solvency certificate of minimum 20% of estimated cost from any Nationalized Bank or of ICICI, HDFC, UTI, IDBI. The certificate should be not old than one year.
3. Details of tool & Tackles in possession relevant to the job.
4. Details of Partner ship deed in case of a partnership firm.
5. Group insurance of all the contract laborers duly engaged through out the contract.
6. Details of P.F. Code No. from appropriate Authority.
7. Copy of Service Tax registration certificate is necessary.

Terms & Conditions:-

- A.** Price bid and Technical Bid should be submitted in separate self addressed sealed envelope provided with the tender documents. ANNEXURE-III

Name of work: Job work for supply & replacement of Self pulsating air header of APU in GT #1 at Gas Based Power Station - UTRAN(Web.18/12/MMD-I)

GENERAL TERMS AND CONDITIONS OF CONTRACT

- (1) **“Contract”** means the documents forming tender and the subsequent agreement that may be entered in to.
“Work” or **“Works”** means: Job work for supply & replacement of Self pulsating air header of APU in GT #1 at Gas Based Power Station - UTRAN.
- (2) **Contractor”** means a firm or an individual undertaking these works or offers the rates for this work.
- (3) The general rules and regulations of the GSECL for tender and contract for works will apply to the extent of the same and not modified herein. The contractor is deemed to have gone through and considered to be fully aware of the conditions mentioned therein.
- (4) **Earnest Money Deposit:**
Tender should be submitted along with Earnest Money Deposit (EMD) at the rate of one percentage (1 %)of estimated cost of the tender, without which tender is liable to be rejected.
- (5) **Security Deposit:**
Successful bidder shall have to pay Security Deposit (SD) equivalent to 10% of the ordered value. Out of this SD, 5% should be paid in cash or demand draft of scheduled bank payable at UGBPS, Utran within seven days of acceptance of order, and balance 5% of the SD will be recovered from first two RA Bills or provide bank Guarantee for the same form any Nationalize Bank. Failure to deposit the SD will entail forfeiture of EMD and the contract shall be treated as terminated. The contractor shall not be allowed to start the work if SD is not paid before the stipulated period. Any loss to the GSECL due to late start of work because of late payment SD shall be the contractor’s liability.
- (6) The amount of Security Deposit will be refunded after the satisfactory completion of the contract after certification by the concerned Suptd. Engineer and after deducting any dues of the GSECL.
- (7) The sublet or to transfer the contract without prior approval of the GSECL shall be treated as breach of contract and it shall be punishable by forfeiting the SD as well as termination of contract.
- (8) The GSECL reserves the right to forfeit the SD in case of any breach of contract and in case of disputes. The decision of I/c Chief Engineer, UGBPS, Utran shall be final, binding and acceptable to the contractor. If the contractor fails to start the work as stipulated the EMD and the SD shall be forfeited.
- (9) **Submission of the bill by the contractor:**
Bills shall be submitted by the contractor for each month on or before the date fixed by the Site In charge, for all works, executed in the previous month and the Site In charge shall take or cause to be taken the requisite measurement for the purpose or having the same verified and the claim so far as it is admissible, shall be adjusted, if possible, within ten days from the presentation of the bills. If the contractor does not submit the

bill, within the time fixed, as aforesaid, the Site In charge may depute a subordinate to measure up the said work in the presence of the contractor or his duly authorized agent, whose counter signature in the measurement list shall be sufficient warrant and the Site In charge may prepare a bill from such list which shall be binding on the contractor in all respect. Along with the R.A. Bill, the contractor should submit material Account wherever applicable, proof of payment of provident fund and other statutory dues, certificate issued by I.R.O. certifying average number of labour deployed during the month and total amount of wages and salaries paid to labour. The R.A. Bills along with the supporting documents will be paid within 30 days.

- (10) **Income Tax**:-Income tax will be deducted at source from each bill as per statutory requirements.
- (11) The GSECL will be entitled to deduct directly from the bills to be paid to the contractor any sum or sums payable by the contractor and which sum/sums the GSECL is required to pay as a principal employer on account of contractor's default in respect of all liabilities referred to in above clauses.
- (12) (a) No sales tax, professional tax or any other taxes, cess or levy, excise duty, octroi, royalty or other duties will be payable by the GSECL against this contract.
 (b) Service tax at the rate prevalent during period of execution of contract and if applicable will be reimbursed on production of certified copy of registration number and paid Challan for payment of service tax from time to time.
- (13) **Documents required to be submitted by the Bidders**:
- a) **Experience Certificates**: At the time of submitting the tender, the contractor shall attach experience certificate(s) of having carried out such/similar type of work either in GSECL or in any other organization.
- b) **Special Tools & Tackles**: The bidder shall have to submit along with the offer, the details of minimum tools, tackles & equipment in possession relevant to the job.
- c) **Provident Fund Code Number**: The contractor shall have to submit along with the offer the details of PF code Number from appropriate authorities, without which the offer is liable to be ignored.
- d) **Solvency**: The contractor shall have to submit a copy of the solvency certificate of minimum 20% of the estimated cost of the tender of any Schedule Bank or HDFC, ICICI, UTI or IDBI Bank. The offer without Solvency certificate is liable to be rejected.
- e) **Audited Annual Accounts**: The contractor shall have to attach along with the tender last three years audited annual accounts (i.e. Profit and Loss account statement and Balance sheet), if the tender estimated value is Rs. 50.00 lacs or more for one year contract and Rs. 1.00 Crore or more for two years contract, otherwise the offer will be liable to be rejected.
- f) **Partnership Deed/Memorandum of Association & Articles of Association**: If the contractor is not a sole proprietor, then the contractor shall have to furnish a copy of the Partnership Deed along with the offer. In case of a Company, the M/A & A/A is required to be submitted without which the offer is likely to be ignored. The contractor shall also submit power of Attorney.
- g) **Labour License for Labour Contract**: The contractor on getting the work order but before starting the work shall have to furnish the copy of Labour License under the Contract Labour (R&A) from the appropriate authorities, without which the contract order is liable to be terminated.
- (14) **Compensation for the Delay**: The time allowed for carrying out the work as entered in the tender shall be strictly observed by the contractor and shall be reckoned from

the date on which the order to commence work is given to the contractor. The work shall throughout the stipulated period of contract be proceeded with all due diligence (time being deemed to be the essence of contract) and the contractor shall pay, as compensation, an amount equal to one percent or such smaller amounts, as the Competent Authority (whose decision in writing shall be final) may decide of the amount of the contracted cost of whole work as shown by the tender for every day that the work remains un-commenced or unfinished after the proper dates. provided always that the total amount of compensation to be paid under the provisions of the clause shall not exceed 10% of the contract cost of the work as shown in the tender.

(15) WAGES TO BE PAID, TIME OF PAYMENT, ETC. BY THE CONTRACTOR :

The Monthly payment of wages to the contract labourers will be compulsorily made through bank. The Contractor shall supply copy of Bank Statement duly stamped by the concern Bank as a Token of Proof towards payment of wages to HR Dept. If any problem may arise for payment of wages through bank, same may inform to Chief Engineer (G) and after approval the payment shall be disbursed in presence of the GSECL representative i.e. HR officer during the working hours in the factory premises and the contractor shall get the entries certified in the register of wages by the representative of the GSECL. Any default will result in cancellation of contract forthwith or else the contractor shall be punishable to the extend of Rs. 100/- per day by way of fine. The contractor shall give his telephone number, address to the GSECL, so that in case of labour unrest etc. the contractor can be contacted.

17. Labour Laws:

The labour laws applicable and amended from time to time have to be followed scrupulously. A few of them for information are as under:

- i). Person below the age of eighteen years shall not be employed for the works
- ii). No female worker shall be employed in the night shift between 19:00 hrs and 06:00 hrs.
- iii). Contractor shall maintain a valid labour license under the Contract Labour (Regulation & Abolition) Act for employing necessary manpower to be required by him. In the absence of such license, the contract shall be liable to be terminated without assigning any reasons thereof.
- iv). The contractor shall, at his own expense, comply with all labour laws and keep the GSECL indemnified in respect thereof. Some of the major liabilities under various labour and industrial laws, which the contractor shall comply with, are as under:
 - a. Payment of contribution of employees (contract labour) as well as employer's (contractor's) contribution towards provident fund, family pension scheme, deposit linked insurance scheme, administration charges, inspection charges, etc., at the rates applicable from time to time by the Government of Gujarat/Government of India or other statutory authorities.
 - b. Payment of deposit and License fee in respect of each contract labour at the rate as revised by the Government from time to time with the Office of the Commissioner of Labour as per the Contract Labour (R&A) Act. License fee as prescribed under the Contract Labour (R&A) Act and rules framed therein, depending upon the number of workers employed by the contractor.
 - c. Paid leave facility and wages as per the provision of the Factories Act at the rate of one day for every 20 days of working.
 - d. No labourers are allowed to enter in power station premises that don't Identity cards as prescribed under the Factories Act or by the Thermal power station with photograph affixed thereon, for identification of workers.

- e. Payment of retrenchment compensation, notice pay and other liabilities as per Industrial Disputes Act, 1947. Any payment to the contractor's employees arising out of any claim or disputes under the Industrial Disputes Act, 1947 or any other labour laws.
 - f. Payment of compensation in case of accidental injury, under Workmen's Compensation Act.
 - g. Provision of crèche if the female labour employed is more than 30.
 - h. Maternity leave as per the provision of the Maternity Benefits Act.
 - i. If any workman engaged by contractor / agency meets with fatal or non fatal accident while on duty, then contractor / agency shall be liable to pay compensation to legal heir or to the workman as case may be as per workman compensation act.
- The above are some of the major liabilities of the contractor in addition to other liabilities prescribed under the various labour laws in force from time to time by the statutory authorities, like State Government/Government of India, which the contractor shall have to comply with.

18. **PROVIDENT FUND AND FAMILY PENSION SCHEME:**

The contractor shall submit along with his bill (month – wise) a statement regarding deductions against employees Provident Fund (EPF) and Family Pension Scheme (FPS) in respect of each concerned employee at the rate of 12% or at the rates made applicable by the government from time to time of wages. The contractor's contribution and the worker's contribution towards PF and FPS shall be deposited by the contractor with the Regional Provident Fund Commissioner, Ahmedabad, or to the authority prescribed under the Act along with the other charges.

19. **DEPOSIT LINKED INSURANCE SCHEME :**

The contractor shall have to deposit 0.50% (half percent) or the rate applicable from time to time of the wages in respect of employees who are members of the PF , as the contribution to the Deposit Linked Insurance Scheme, with the Regional Provident Fund Commissioner.

20 **MINIMUM WAGES ACT :**

The contractor shall pay prevailing minimum wages as applicable from time to time to the laborers engaged by him as per the Minimum Wages Act, in presence of the GSECL's officer or representative.

21. **ADMINISTRATIVE CHARGES:**

Administrative charges for maintaining Provident Fund account shall be deposited by the contractor with the Regional Provident Fund Commissioner, Ahmedabad, at the rates applicable.

22. **PAID LEAVE FACILITY :**

Paid leave facility at the rate of one day for every twenty days of actual work by the contract labour shall be provided by the contractor to his workers. He shall maintain leave record / verified and approved / certified by the authorized officer of the GSECL.

23. **E.S.I. Act:**

The contractors shall comply with the provisions of E.S.I. Act wherever applicable as per the prevailing provisions of the Act and as amended from time to time.

24. Safety:

The contractor shall strictly observe all safety rules and provide safety equipment to the contract labourers as per the Factories Act, 1948, and whatever amendments made from time to time to avoid any chance of accident. The contractor shall strictly observe all instructions of Safety Officer and Factory Inspector to avoid any chance of accident.

25. LABOUR LICENSE FOR LABOUR CONTRACT : :

The Contractor / Agency shall have to obtain the copy of Labour Contract License under contract Labour (Regulation & Abolition) Act from the appropriate authorities before commencement of work.

26. WORKMEN'S COMPENSATION FUND AND EMPLOYER'S LIABILITY INSURANCE:

Insurance shall be affected for all the contract employees engaged in the performance of this contract. If any of the work is sublet after due permission in writing from the GSECL, the contractor shall require the sub – contractor to provide workmen's compensation and employer's liability insurance for the later employees, unless such employees are covered under the contractor's insurance. It shall be the liability of contractor for employees of his sub – contractor. The contractor must insure that all the laborers may cover before starting the works

27. SUBMISSION OF RETURNS & MAINTENANCE OF RECORDS:

The contractor shall submit the returns under the Contract Labour Act, payment of Bonus Act, Payment of Gratuity Act etc. and shall have to maintain all up to date records / registers in respect his employee as prescribed under various Labour Laws and produce the same as and when demanded by GSECL's or Govt. appropriate authorities.

28. CONTRACTOR TO INDEMNIFY THE GSECL :

The contractor shall indemnify and keep indemnified the GSECL and every member, officer and employees of the GSECL, including Engineer – in – Charge and his staff, against all actions, Proceedings, claims, demands, costs and expenses whatever arising out of or in connection with the matters referred in above clauses and elsewhere and against all actions, claims, demands, Costa and expenses which may be made against the GSECK, by any workman / employee of the contractor or sub – contractor or any other person under any law, rules or regulations having the force of law, including, but not limited to, claims against the owner under Workmen's Compensation Act, 1970. The force of law, including, but not be liable for or in respect of or in consequence of any accident or injury to any workman or other person in the employment of the contractor. The contractor shall indemnify and keep indemnified.

The GSECL against all such damages and compensation and against all claims, demands, proceeding costs, charges and expenses whatever in respect thereof or in relation thereto.

The contractor shall also indemnify GSECL in all respect against any liability due to breach of legal provisions contained in any of the Labour Laws.

The Contractor shall also indemnify GSECL for injury or damage to third party other than employees of the GSECL contractor or sub – contractor.

29. Contractor / Agency shall have to issue the contractual appointment letter for a specific period to their Labour engaged during the contract period each and every

instance & should narrated clear out terms & conditions for the liabilities of the concerned employees.

30. As a contractor, the contractor shall be responsible and liable to pay difference in wages, if any, and / or observe the revised service conditions that may be awarded by the Honorable Industrial Tribunal effective from the date directed in the award.
31. The contractor must be maintaining regular Labour record and should be paying all acquired benefits to Labour force and contractor should obtain certificates to this effect from HR Officer of GSECL.
32. The contractor will make arrangements at his own cost to insure all men, materials and equipment employed for this work. The GSECL will to be responsible for any loss or damage either to the contractor's personnel or his equipment.
33. Dispute, if any, taking place between the contractor and laborers must be intimated to IRO, GBPS, Utran, immediately.
34. Any casualty will also have to be borne by the contractor for the period the contract continues.
35. The Contractor shall deposit 15 days salary at the rate of last drawn salary for every completed one year of services for each worker for the liabilities of Gratuity.
36. The Contractor / Agency shall have to produce / submit the copy of Wage Register, Muster Roll, PF Deposition Challan, PF Schedule, Copy of Bank Statement duly stamped by the concern Bank and relevant records under various Labour Laws for the contract work to HR Department to ensure compliance to provisions of various legislations.
37. Attendance of contract labourers will be through punching machines for which punching machines shall installed to facilitate the contractors by GSECL for which monthly charges of Rs. 10/- will be levied on contractor as administrative charges.

“ All question, dispute or differences whatsoever which may at any time arise between the parties to this agreement touching the agreement or subject matter thereof, arising out or in relation thee to and whether as to construction or otherwise shall be referred to the decision of the sole Arbitrator, appointed by the chairman & MD ,GSECL for that purpose, who shall be retired High Court Judge or a retired District and Sessions Judge, and the decision of the said Arbitrator shall be final and binding upon the parties, Reference to the Arbitrator shall be governed by the provisions of the Arbitration and conciliation act-1996 as amended from time to time and rules made there under. The Arbitration proceeding shall be conducted at HO, GSECL, Vadodara or at such place as the sole Arbitrator may be determined. The award of sole Arbitrator shall be final be final and binding upon the parties”

“ All question, dispute or differences whatsoever which may at any time arise between the parties to this contract in connection with the contract or any matter arising

out of or in relation thereto shall be referred to the Gujarat Public Works Contract Dispute Arbitration Tribunal as per the provision of the Gujarat Public Works Contract Dispute Arbitration Tribunal act-1992” “In case where divisible orders for supply and works are placed instead of indivisible supply and works order, the arbitration clause for such divisible supply order shall be incorporated as per Sr. A and for divisible work order the Arbitration clause shall be as per Sr no- B above.”

- 39** **Labour Escalation:** The contractor shall pay minimum wages to his labourers as per the Minimum Wages Act, 1948 and rules therein, as applicable from time to time, in pursuance to the State government notification. The concerned contractor, after making such payment to his labourers, shall submit the details of the payment with the certification of Labour Welfare Officer / Industrial Relations Officer. **However, no labour escalation or any type of escalation. will be payable by GSECL to the contractor as this is a firm price contract through out the period of contract.**
- 40** The GSECL reserves the right to terminate this contract at any time during its currency without giving notice of termination or any reason thereof.
- 41** **Time Limit:** The time limit for completion of this contract works, if awarded, is **Thirty days.**
- 42** The contract will remain in effect for the period of **six months from the date of commencement letter of contract.** GSECL at any time during the tenure of the contract may terminate the same at its sole discretion without assigning any reason, if it is observed that obligations under this contract are not performed up to the satisfaction of GSECL. The contractor will, however, not be entitled for any compensation for such premature termination of contract.
- 43** In case of default, the work will be got done through other agency / agencies at the risk and cost of the original contractor, and the GSECL shall be entitled to recover such expenses from defaulting contractor by such methods as deemed fit. The contractor shall not, however, be entitled to terminate the contract or stop works undertaken by him before expiry of the contract period / extended period due to any reason whatsoever.
- 44** Under the contract, the contractor should either himself be present at the site or should nominate persons in writing, who must be available at site and who should be authorized to take decisions about the works and receive the instructions from Site In charge of the work at any time. In absence of any responsible man of contractor at the time of any emergency, adhoc decision of Site In charge will be binding to the contractor.
- 45** The contractor is bound to execute the work for any item as per the instruction of the Site In charge. On refusal to do so, the work will be carried out at the risk and cost of contractor by using the contractor's tools and tackles, for which no compensation whatsoever shall be payable to the contractor.
- 46** If any immovable articles/tools/equipment will be found stolen from the working place, the contractor would be held responsible and cost will be recovered from his bill.

- 47 For any conflict and ambiguity, the decision of the Chief Engineer shall be final and binding on the contractor
- 48 Sealed tender should be super scribed as “Tender for Job work for supply & replacement of Self pulsating air header of APU in GT #1 at Gas Based Power Station - UTRAN. Technical Bid & Price Bid should be sent by R.P.A.D. only so as to reach this office before last date & time of acceptance of the tender. GSECL will not be responsible for any postal delay. Tender received after last date and time of acceptance will not be considered.
- 49 The contractor shall quote only certain percentage of rates above or below the estimated rates, i.e., contractor should quote either, say A% above the estimate or B% below the estimate of all the items. The contractor should not quote different percentage for different items. Tenders received with different percentage rates for different items shall be liable to be rejected. The contractor should quote only percentage higher/lower in figures as well as in words in Schedule-B. In case of not mentioning clearly above/below the estimate, the Board shall consider the quoted percentage below the estimate and the contractor must have to honor this, failing which suitable actions may be taken, considering this as dishonor and/or summary rejection of offer without assigning any reason thereof as deemed fit by Chief Engineer. The rate quoted should be inclusive of all taxes and expenses, if any. Nothing will be paid extra as a part of contract unless & until, it is specified in the tender documents by GSECL.
- 50 **The rates quoted shall be firm and valid for 180 days for acceptance from the date of opening.**
- 51 **The contractor, if desired, can see the plant and site on any working day and during working hours with permission of the Chief Engineer.**
- 52 Conditional tender is liable to be rejected withdrawal or insertion of conditions unilaterally after opening of tenders will not be permitted unless it is so desired by the GSECL.
- 53 I/c Chief Engineer, UGBPS, Utran, reserves the right to reject any or all tenders without assigning any reasons thereof.
- 54 Before starting the work, the contractor should contract Industrial Relation Officer for all formalities and obtaining the gate passes of his labourers and for other formalities.
- 55 Office correspondence will be carried out in English language, and if at any time to facilitate the contractor, Gujarati translation may be furnished, if deemed fit. The English version will be the correct one and the same only will held good for legal matters.
- 56 The contractor should intimate to the office the name and address of authorized and responsible representatives, so that our field officers can contact them when required in connection with the execution of the said works.
