In accordance with the terms and conditions hereafter set forth, enter the following order for my new responsive mobile enabled website.

This agreement, dated _____ made by _____ agrees to make monthly payments of \$99.00 to PageLink USA, LLC., hereafter known as "PageLink," in exchange for the foundation package* and hosting of my responsive mobile enabled site. This payment schedule is enforceable by law, and you authorize PageLink to make monthly payments using my credit card listed below for a period of twelve (12) months. If payment should not be delivered at all, PageLink will be entitled to full payment remaining on contract. The total value of this agreement is \$1,188.00. This contract contains the entire terms of the relationship between the parties hereto and is acknowledged by advertiser's signature. Once this contract is signed, it cannot be canceled.

The laws of the State of New Jersey shall govern the validity, construction and effect of this Agreement. All lawsuits arising out of this agreement, wherever derived, shall be resolved in Essex County, State of New Jersey.

This Agreement constitutes the entire agreement and there are no oral or other representations regarding the subject of this Agreement that are binding on either party. All changes to this Agreement must be in writing, signed by both parties. It is understood and agreed that e-mail correspondence shall not constitute "a writing" to this agreement unless expressly included herein.

Both parties will receive a printed copy of this agreement, and will be responsible for upholding its terms.
