Bid will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours of the deadline for submission of bids at the address below. There will be no objection to open the Bid in the absence of any bidders or his/her representative.

7. Information or data submitted by the bidder which is either incomplete or unclear or not substantiated by supporting documents shall not be considered for evaluation.
8. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
9. If the last date of purchasing, submission and opening falls on a government holiday, it shall be extended to the next working day.
10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
11. Other related rules and regulations are as per PPA-2063 and PPR-2064.

Bidders, who choose to submit the bid by e-bidding system, must submit the original copies (**Hard copy**) of mandatory documents to DUDBC, New Town Project Office, Chaurjahari, Rukum within 7 days of last day of bid submission. Non submission of hard copy by the bidder within specified time shall be considered as non-responsive and may cause forfeiture of bid security.
