1. Photographer shall reserve the date and time agreed upon, and all reservation fees are non-refundable. If it is necessary to change or reschedule the event to a different date or time, and the client provides notice of the change and new date and time sixty days prior to the original date or time, we will apply the deposit to the new date or time. All payments for services must be received on or before the date due of the reservation for services will be cancelled and all deposits retained by Photographer.
2. Although all care will be taken with the negatives and photographs taken, Photographer limits any liability for loss, damage, or failure to deliver pictures for any reason to return all deposits made. Photographer cannot be responsible for photographs that are not made due to late starts, missing bridal party or family members, extended ceremonies and/or receiving lines or other circumstances over which Photographer has no control.
3. Client shall reserve the ceremony location or facility for sufficient time and for the exclusive purpose of completing the formal photography session. Client shall also reserve time for any pre-ceremony and/or post ceremony coverage required.
4. It is understood that Photographer is the exclusive official photographer to perform photographic services and the taking and/or selling of photographs by other professionals is prohibited. Although the taking of pictures by others (non-professionals) is not expressly restricted, buyer understands that flash photography by others during the formal session can result in delays and degraded picture quality. Please note that Photographer cannot guarantee the result, quality or number of exposures taken if flash photography is done by others during the formal session.
5. Any client that requests the photographer to remain beyond the agreed on time limit of this agreement is required to pay an overtime fee of \$250 for every hour or partial hour that the photographer stays beyond the agreed upon time. This overtime fee is payable at the time the preview proofs are picked up by the client.
