This risk assessment form has been developed in conjunction with the Local Authority Inclusion Service and Education Psychologists.

This form should be completed when the headteacher deems it necessary to undertake a risk assessment as a result of unacceptable pupil behaviour.

Advice on the content and completion of this risk assessment form is provided by Local Authority Human Resources Officers.

Advice and support to the headteacher regarding advice on pupil behaviour is provided by Educational Psychologists.

Advice and support to the headteacher regarding statemented pupils and inclusion/exclusion issues is provided by Inclusion Services.

It is the headteacher's responsibility, with advice and guidance as stated above, to make decisions on actions to be taken on completion of this pupil risk assessment form.

Completed Risk Assessment forms must be held, as confidential documents, by the headteacher, and a summary of the overall findings made available to the pupil, parents/carers and relevant others.


Pupil Risk Assessment - Introduction

Due to changes in lifestyle circumstances and educational progress, some pupils may find themselves considering changes in their educational provision. This will be considered at a Review meeting of either their Individual Education/Behaviour Plan (IEP) or their Pastoral Support Plan (PSP). Parents/carers, pupils, school representatives and all appropriate others will be invited to this meeting.


- If considered appropriate and necessary, a Risk Assessment may be recommended, prior to a change of educational provision being considered. The headteacher is responsible for completing risk assessments and feedback to relevant parties.
- The accompanying Risk Assessment has been agreed, following multi-agency consultation, as a suitable and sufficient assessment of risk for the proposed change in educational provision.
- If appropriate, completion of the assessment form will be made by other parties such as teaching and support staff, parents/carers, educational social workers, youth offending team representatives, social workers, educational psychologists and medical representatives. The assessment may also be completed by the pupil, if felt appropriate and beneficial.
- The assessment should focus on behaviours:
 - a) since the last risk assessment, or
 - b) from the period of time that their circumstances changed and behaviours gave cause for comment, e.g. since behaviour targets were written on the IEP
- The completed assessment forms will be returned to the headteacher within 10 days of distribution.
- Once the Risk Assessment form(s) has been completed, responses will be collated and examined and the Risk Assessment Summary (RAS) will then be completed. This will be done as quickly as possible.
- The RAS may be made available to parents/carers, pupils and all of those identified as being relevant to the assessed pupil.
- The completed Risk Assessment forms will be held by the headteacher and remain CONFIDENTIAL.
- There is a legal requirement to review a Risk Assessment whenever circumstances change. This should be identified via regular monitoring of IEPs and/or PSPs.




Draft Risk Assessment Procedure

Risk Assessment requirement identified




