 RE: MEAL PRICES FOR 2017-18
 FOCUS: APPROVE THE RATES FOR BREAKFAST AND LUNCH IN ACCORDANCE WITH THE HUNGER-FREE KIDS ACT OF 2010

Effective July 1, 2011, Section 205 of the Child Nutrition and WIC Reauthorization Healthy, Hunger-Free Kids Act of 2010 requires schools participating in the National School Lunch Program to ensure that schools are providing the same level of financial support for lunches served to paid students as they are to students who are eligible for free lunches.

Schools currently charging, on average, less than \$2.86 for a paid lunch are required to either gradually increase prices or provide additional financial support from the general fund. The \$2.86 is the difference between the Free reimbursement rate for lunch (\$3.22) and the Full Price reimbursement rate for lunch (\$0.36).

The federal reimbursement rates for 2016-17 are as follows:
