Refunds are issued in like-kind form with the manner of payment for purchase. Refunds take up to 30 days to process. Jusuru will replace returned Jusuru product provided the following conditions are met: (i) the Jusuru product is returned to Jusuru by the iRep through whom the purchase was made, (ii) Jusuru must receive the Jusuru product within 10 business days of the date the product was returned to the Jusuru iRep, (iii) the return is accompanied by (1) a signed statement from the customer identifying the reason for the return, (2) a copy of the original sales receipt, (3) the unused portion of the Jusuru product in its original container, and (4) the name, address and telephone number of the customer. Proper packing materials must be used by the customer in return shipping the unused product to Jusuru and economy shipping is required.

You, the Buyer, may cancel this transaction at any time prior to midnight of the third business day after the date of this transaction. See the Notice of Cancellation form for an explanation of the reverse side.
