Weatherization Program Specific:

The Weatherization program has high standards and strict requirements set forth through the Federal Department of Energy. The questions asked within this document are to assist with the identification of those contractors most able to meet the requirements of the program. All submitting contractors will be notified of their status.

KOOTASCA conducts Weatherization for approximately 25 households per year. We are looking for 3-4 Residential Building contractors and 3-4 Mechanical contractors to meet this demand.

Evaluations will be scored with assigned points for each question. Evaluation point totals will be assessed on a bell curve to establish an Eligibility List of qualified contractors deemed most advantageous in meeting Weatherization Program objectives. Contractors that make the Eligibility List will be required to attend an informational meeting on Weatherization Program requirements prior to contracting with KOOTASCA. All Weatherization work orders will be awarded through individual bids sent to all contractors on the list or on a rotational basis if contractors agree to a set material and labor price list structure.

Section 1. Minimum Requirements – Failure to meet any of the requirements listed in this section will prevent KOOTASCA from contracting with your company to perform Weatherization until such time that all requirements can be met.

- A) All Contractors must be licensed and bonded as required by pertinent laws, ordinances, regulations, or codes
- B) All Contractors must not be debarred from receiving Federal Grant funds
- C) All Contractors must provide authorization for background checks through the Minnesota Bureau of Criminal Apprehension's Computerized Criminal History system for the business owner and all workers assigned to Weatherization projects
- D) All Contractors must be willing to provide lien waivers to the Weatherization Service Provider (KOOTASCA) for all work completed in accordance with Minnesota Statute 514
- E) All Contractors must provide labor and materials warranty for one year from the date of final inspection.
- F) All Contractors must provide Certificate of Liability Insurance at \$1,000,000 Combined Single limit for bodily injury, \$500,000 Property Damage, per occurrence and aggregate
- G) All Contractors must provide Certificate of Workman's Compensation
- H) All Contractors must enter into a written agreement/standard KOOTASCA Contractor Contract specifying terms and conditions under which work will be performed, including consequences for non-compliance or underperformance
- I) Residential building contractors must have a current EPA certification for LEAD Safe Firm
- J) Residential building contractors must have current EPA Lead Safe Renovator certifications for all workers assigned to Weatherization projects
