- 4. Issue of Challan Counterfoils:** It shall be emailed to your email address mentioned in this form. If email address is not provided then the counterfoil shall have to be collected from the branch after 3 working days.
- The Tax Payment Request Form has to be duly signed & stamped by all authorized signatories to the account, as per the Mode of Operation on the account. No requests shall be executed even if a single signatory to the account has not signed & stamped the form.
- This request shall be processed subject to availability of sufficient funds in the account to be debited only.

(as applicable), tax deduction account no. etc., solely lies with the customers & any errors/ losses/ penalties/ late payment fees/ delay payment charges etc. due to late payment or non-payment of customer's tax arising out of such errors caused due to providing incorrect/ incomplete information/ details, shall be customer's sole responsibility.
