In case of discrepancy between the Unit Price and the Item Cost set forth for a unit basis item, the unit price shall prevail and shall be utilized as the basis for determining the lowest responsive, responsible Bidder. However, if the amount set forth as a unit price is ambiguous, unintelligible or uncertain for any cause, or is omitted, or is the same amount as the entry in the "Item Cost" column, then the amount set forth in the "Item Cost" column for the item shall prevail and shall be divided by the estimated quantity for the item and the price thus obtained shall be the Unit Price.

For purposes of evaluating Bids, the City will correct any apparent errors in the extension of unit prices and any apparent errors in the addition of lump sum and extended prices.

The estimated quantities for Unit Price items are for purposes of comparing Bids only and the City makes no representation that the actual quantities of work performed will not vary from the estimates. Final payment shall be determined by the Engineer from measured quantities of work performed based upon the Unit Price.

- a. See attached detail PPR-G-15 Prelim PDF (G-15)

6. Bid Item #17 identifies we are to install (2) new Air and Vacuum Release Valves, but the drawings do not identify where. Please provide a location as to where the new Air and Vacuum Release Valves are to be installed.

- a. The Bid item #17 quantity should be 1.

7. Bid Item #16 has a quantity of 0. Is this accurate? Please advise.

- a. Delete this bid item.

8. Bid items #31-35 lists CL235, but the drawings indicate CL305. What class should we follow?

- a. The specifications call out DR 18 which means CL235 and supersede the drawings. The Bid Items are identified correctly.

9. What is the size of the Air Vac. Valve used on the Air.& Vacuum Release?

The Air Vac should be in accordance with Detail G8 and 1-inch in size.

10. On Sheet 3 of the Construction Notes, note 29 and 58 are the same. Should Note 58 be a 4"x 3" Reducer? Please advise.

- a. Replace construction note 58 as shown on the drawings with "PROVIDE 4" X 3" D.I. REDUCER (MJ X MJ) WITH EBAA IRON MEGALUG MECHANICAL JOINT RESTRAINT RETAINER GLANDS AND CONCRETE THRUST BLOCK PER CITY OF PASO ROBLES STANDARD DRAWING NO. G-7.1, SHEET 4."

11. For Bid Item #9, I took off a quantity of 4 EA, but the bid quantity is 15 EA. Could you please clarify the location of the other 11 fittings or what should be included in the 15?

- a. The Bid item #9 quantity should be 4.

12. What are the limits of the paving for trench restoration? Are we to just assume anything within 2' of the curb & gutter will get repaved back to the lip?

- Detail U-2 and Trench Section A detail on sheet 5 indicates paving restoration limits.

13. On Sheet #11, STA 32+45.70 – Water Service. I could not find this service in the field. Could you provide more information as what size service this is in the field and the location?

- The water meter is located in back of the sidewalk just in front of the backflow preventer.

14. At address 3401 Spring Street, I noticed there had been repetitive work done to this service. I am assuming there were leaks and issues repairing it. The design calls out for us to tie-in to this service, but we are proposing to replace it. Could we proceed with installing a new service to this customer or handle this as a change order if awarded the project? Please advise.

- The project design calls out new water services at each location. This includes the tap at the main, the service line, meter and meter box, and all incidental items for a new service.

15. At 3411 Spring Street, there is a pine tree whose roots have grown and uprooted most of the existing drive approach, various panels of sidewalk, and sections of the south bound #2 lane. How are we to handle this tree and its roots that will be encountered to tie-in the service and install the communication conduits? Should this be handled as a change order if awarded the project? Also, would we want to have an arborist onsite and, if so, would the city of Paso Robles cover this cost?

- The project plans do not call out a water service replacement at the location as identified.

16. For the Megalug T-Bolts and Joint Restraints, will stainless steel bolts and rods be required?

- The City's standard for bolts, nuts and rods is low alloy.

17. On the Romac Flex Couplings, will stainless steel bolts be required?

- The City's standard for bolts, nuts and rods is low alloy.

18. For Romac Couplings, will epoxy coating be required?

- The couplings shall be epoxy coated.

19. I don't see any Blow-offs identified in the water main design. Can you provide a location and quantity for Blow-offs?

The design does not include blow-offs. Any blow-offs installed by the contractor for filling or draining of the line during construction and/or testing shall be an incidental expense of the project, and at no extra expense to the City.

20. Can we move new fire hydrants to the side a few feet from the existing fire hydrants? The only alternative is to remove the old ones and place new ones in the exact spot. This means the hydrants would be out of commission for a period of time.

- It is acceptable to place a new fire hydrant a few feet from the existing hydrant. The existing fire hydrant will need to be completely removed and the surface restored after pressure testing and acceptance of the new line and fire hydrant.

21. Can we pressure test against new valves?

- It is acceptable to pressure test against a new valve.

22. Bid item #24 calls out for 78 total of 10" gate valve. We believe there is only 1 new one.

- a. The Bid item #24 quantity should be 2. See sheets 3 and 16 of the project plans.

23. Bid item #28 calls for 2 new fire hydrants. We have found a total of 3 on sheets 8,11 and 13.

a. The Bid item #28 quantity should be 3.

24. Do the water meter boxes need replacing if they are relatively new?

- The project design includes the replacement of all water meter boxes. Any water meter box that is repurposed in the field should be considered as a deduct change order.

25. If a 2 sk concrete slurry mix is used for backfill, can we bring it up to within 6" of final ac paving?


- See requirement of Trench Section B sheet 6, which identified the 2 sack slurry to be within 3" of the final ac.

26. As far as the conduit trench, does the slurry backfill terminate at finished grade?

The conduit trench slurry backfill will terminate at the finished grade. It is the intent of the city to repave this section in the near future.

## 3-INCH TIE OVER TO EXISTING


