61 year old **Bridget lives in Northfield, Birmingham** and has a diagnosis of **Friedreich's Ataxia** which is a slow progressive degeneration of the nerve tissue in the spinal cord affecting the limbs, head and neck but not mental capacity.

As a result of this dreadful disorder Bridget has lost the use of her legs and is now a full time wheelchair user, her arms are also affected, but her main concern is the loss of her voice. It's deterioration is becoming increasingly noticeable in the mornings and evenings when she is tired and as it gets worse she will become more and more isolated. She desperately needs a speech aid to help give her back the social interaction that has so cruelly been taken away.

Bridget's husband is her main carer, but due to his own health problems and not being able to take her out as he used to, she's now virtually housebound. A communication aid would help her regain social contact, self esteem and the independence she so desperately misses but unfortunately they cannot afford this system themselves and have turned to us for help. Her husband describes her as a caring, down to earth person who loves animals, children, reading and watching TV, especially gardening programmes but her greatest wish of all would be able to Skype her son in Australia while she still can.

Bridget's Occupational Therapist conducted trials with her on various devices and decided that a Grid Pad Pro would suit her particular needs best as she will be able to use the text to speech facility when her voice is weak. It also has environmental controls built in enabling her to control devices in the home such as televisions and lights. The cost of this system with a wheelchair mount is £3,623.00 and we would be extremely grateful if a donation, no matter how small, could be made or pledged towards this cost
