**NHS Fife Primary Care Emergency Services: Option Appraisal 23<sup>rd</sup> April 2013**

NHS Fife Primary Care Emergency Service (PCES) is being reviewed to ensure the service provided for Fife residents is Person Centred, Safe, Effective, Efficient, Equitable and Timely in line with:

- The Healthcare Quality Strategy for NHS Scotland (May 2010)<sup>1</sup>;
- The Provision of Safe and Effective Primary Medical Services Out of Hours (2004)<sup>2</sup>;
- Quality Indicators for Primary Care Out of Hours Services (2012)<sup>3</sup>.

To date, NHS Fife has undertaken significant work, discussed possible options for PCES with groups including its three Community Health Partnership Committees, Patient and Public Partnership fora, Community Groups and local Politicians. As the next stage of the process, an Option Appraisal session is to be held on **Tuesday 23<sup>rd</sup> April 2013**, at the **College of Nursing, Forth Avenue, Kirkcaldy, KY2 5YS**. It is anticipated that a **full day** will be given over to the process.

I am writing to invite you and the Vice Chair, or one other representative for Dunfermline & West Fife CHP to take part in the Option Appraisal, which will inform the future configuration of NHS Fife Primary Care Emergency Service. The final decision regarding the service will be taken by NHS Fife Board.
