## TERMS & CONDITIONS OF SALE

1. The Seller is selling the Vehicle as is, as seen, and without warranty or guarantee of any kind whatsoever, save for such that cannot be excluded by statute.
2. Save for the matters stated within this Contract, the Seller makes no representations to the Buyer with respect to the state, condition and functionality of the Vehicle.
3. This Contract embodies the entire agreement between the parties and supersedes all previous agreements, understandings, negotiations, warranties and representations.
4. The Seller warrants that the Vehicle is owned by the Seller and the Seller has full right and authority to sell the Vehicle to the Purchaser and deliver it into their possession.





5. The Seller warrants that, to their best knowledge and belief, the Vehicle is free of any financial or other encumbrances that may affect the title of the Vehicle.
6. The Buyer has offered to purchase the abovenamed Vehicle from the Seller for the Purchase Price stated above, and upon the terms and conditions stated herein.
7. The Buyer acknowledges and agrees that it has fully inspected or otherwise had the opportunity to fully inspect the Vehicle prior to offering to purchase it on these terms.
8. The Buyer is satisfied with and accepts the state, condition and functionality of the Vehicle.
9. All risks and responsibilities pass to the Buyer once the Payment Price is paid and the Buyer takes possession of the Vehicle.
10. The Buyer accepts full responsibility for any charges, repairs, duty, fines or any other costs incurred as a consequence of ownership and/or possession of the Vehicle from the Date of Contract and transfer of such to the Seller.
11. This sale is subject to and conditional upon payment of the Purchase Price by the Buyer, in full, the receipt of which must be acknowledged by the Seller hereinunder.
12. If the Purchase Price is not paid, the Seller may either in their absolute discretion: affirm their rights under this Contract for payment of the Purchase Price (or the balance outstanding), plus interest accruing at 25% per annum; or rescind this Contract and retake ownership and possession of the Vehicle, at the cost of the Buyer.
13. This document is governed by the law in force in Queensland, Australia.
