Electricity is available, vendor must provide own extension cord. Vendors are responsible for leaving the area in the same condition as they found it. Vendors must contain their operations within their allocated space. No exceptions. Space location is at the discretion of Salty Red Dog Marketing, LLC/House of Katia.
