

AGREEMENT BOND

Know all men by these presence, that we

1) _____, S/o. _____ selected
as SCT PC() vide Regd.No. _____(herein after referred to as
the obliger) residing at _____
_____ (V) _____ Mandal _____ Dist and

2) _____ S/o. _____
(herein after referred to as the Surety) residing
at _____ (V) _____ Mandal
_____ Dist are jointly and severally held and firmly bound into the

Governor of Telangana (Hereinafter called the Governor) which expression shall,
where the context admits to include his successor-in-office and assigns, in sum
of Rs.5,000/- (Rupees: Five Thousand Only) together with interest thereon from
the date of demand at Government rates for the time being in force on
Government loans to be paid to the Government for which payment well and truly
to be made, we hereby bind ourselves, our representatives, heirs, executors,
administrators, and legal representatives, jointly and severally firmly by these
presence.

2) Whereas the above bounded Obliger now working as _____ is selected as Stipendiary, Trainee Cadet Police Constable and deputed for the Basic Induction Training at PTC/BTC _____ for a period of (9) months at the expenses of the Government subject to the terms and conditions herein after mention.

3) Whereas the above said surety has freely and voluntarily agreed to stand and both hereby surety for the said Obliger for the due fulfillment of the conditions hereinafter set out.

4) Now the condition of the above written bound is that, the above bounder Obliger shall undergo the full course of training prescribed by the Government at PTC/BTC _____ and shall during such course of training abide by the Government Servants Conduct Rules and all other rules regulations and laid down by the Government to be followed during such period of training and shall after the successful completion of the training serve the Government either in the particular department for which the special training is being given or in the reconstituted or realigned department as the case may be, for a period of 5 years, commencing from the date from which his service may be required.

5) And if the above bounder Obliger, either resigns the appointment or is discharged from the course due to misconduct, long absence or for any other fault of his or fails to complete the course of training to the satisfaction of the Government or fails to pass the examination in prescribed subjects for a transfer to the other Department for which the special training undergone by them is not usefully during the stipulated period of 5 years, after they turn to duty the above bounden as any shall at all times within 15 days of notice in writing from the Government, pay all sums of money expended by the Government of the training allowance _____ with interest thereon at Government rates for the time being in force of the Government loans calculated from the respective dates of the payments.

6) And the Government without prejudice to any other rights may recover such sum or sums of money as may be due from the above bounden obliger and surety by virtue of this bond as if ever areas of land revenue under the Telangana Revenue Recovery Act, 1864 (Act 11 of 1864).

7) If the above conditions are carried out, then this bond of obligation shall be void and of no effect, otherwise the same shall be and remained in full force and virtue.
