

Benefits

The benefits of using diamond cutting techniques as opposed to conventional construction material removal methods are quite comprehensive. Diamond cutting techniques are vibration free cutting thus protects the adjacent structure. Diamond cutting techniques also benefit the environment (dust free, low noise levels, minimum amount of debris) and site access (can be used in confined spaces and underwater and is remote machine operation possible).

Core Diamond Drilling

Diamond drilling is a quiet, non – percussive way of forming holes and openings, the result is free from bursting or spalling and requires little or no reinstatement work

The main type of diamond drilling used : wet drilling - This technique provides precise holes through all types of base materials such as mass concrete , reinforced concrete , brick masonry, and block work .

Our diamond drilling size range is from 6 mm diameter for small anchor bolts and dowel bars to 350 mm diameter (single holes) for installing large diameter pipes. We have special sizes core bits which can drill up to a depth of 1000 MM.

Wall Sawing

This service is provided with the use of Hydraulic diamond wall saw with remote control. We can cut up to a depth of 650 mm in reinforced concrete and cutting line can be both horizontal and vertical.

The primary advantage is to have vibration free demolition and protect the other structure of the building. The equipment can be used in most areas for flush, inverted or angled position. Our skilled operators are capable of handling any challenging situations.
