<input type="checkbox"/> Information about Your Divorce	<b>Date of separation</b> (The date the spouses decided to stop living as husband and wife.)  <b>Grounds for divorce</b> (The reason you are filing for divorce. Most states recognize "no-fault" divorce, in which both parties declare they cannot get along, and no one is to blame for the breakup of the marriage. Wherever possible, LegalZoom will prepare your divorce paperwork as "no-fault." Please confirm the grounds for your divorce with your spouse.)  <b>Restoration of prior or maiden name</b> (If the wife changed her name, she may request that the court restore her former name as part of the divorce proceedings.)

<input type="checkbox"/> Marital Asset Information	<b>Complete the Property and Debt Worksheet</b> (Provided prior to the property & debt section.)
