2.2 Minimum Pre-Qualification Criteria

- i. Bidder should have the experience of completion of similar works during last 7 years ending last day of month previous to the one in which Applicant are invited should be either of the following.
 - (a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost, Certificate should be attached.
Or
 - (b) Two similar completed works each costing not less than the amount equal to 60% of the estimated cost, Certificate should be attached.
Or
 - (c) One similar completed work costing not less than the amount equal to 80% of the estimated cost. Certificate should be attached.
For evaluation purpose, the completion cost of works mentioned in the completion certificate shall be enhanced by 7% per annum till the end of month prior to date of NIT.
- ii. The applicant should have completed at-least One similar work costing not less than the amount equal to 40% of the project cost (average of column "Pre-qualification limit (Project Cost between)") "with Central Government Department/State Government Department/Central Autonomous Body/Central Public Sector undertaking/State public sector undertaking as per clause (i) above within last 7 years ending last day of month previous to the one in which Request for proposal is invited. For evaluation purpose, the completion cost of works mentioned in the completion certificate shall be enhanced by 7% per annum till the end of month prior to date of Request for proposal. Only green field project will be considered.
- iii. **Similar works mean:** Civil work comprising - RCC framed structure (G+2 & above) Institutional/Residential/Industrial/ hospital building including MEP services like electrification, Sanitary & Water Supply, Drainage and waste management, Firefighting & Site development etc. from Central / State Govt. Departments / PSUs and/or Autonomous bodies/Public Limited Company with supporting evidence & TDS certificate/ Private Ltd. Company with TDS Certificate. Only green field project will be considered.
- iv. **Turnover:** Average Annual Financial Turnover on construction works during the last three years, ending 31" March of the previous financial year i.e. 2019-20, should be at least 50% of the estimated cost. Audited Annual Report & Balance Sheets along with profit and loss account duly Certified by Chartered Accountant is to be enclosed.
- v. Should not have incurred any losses in more than two years during the immediate last five consecutive financial years, ending 31.03.2020, Copies of Annual report / balance sheet and a Certificate from Chartered Accountant along with UDIN issued by ICAI is also to be submitted.
- vi. Should have valid Permanent Account Number of Income Tax (Copy of PAN to be enclosed).
- vii. Joint Ventures / consortia of firms / companies shall not allowed.

- viii. Should have a solvency of 40% of estimated project cost of empanelment issued by his bankers (PSU Banks/any reputed scheduled bank only) in the name of bidder. The solvency should not have been issued earlier than one year of last date of submission of Request for proposal.
- ix. The applicant must have adequate organizational setup as well as having manpower in sufficient number of experienced personnel, technical know-how, and infrastructure to complete the project well within time frame.
- x. The credentials of the Bidders with respect to Technical & Financial criteria shall be verified and inspection of the works, if required, to be carried out by EPI. If not found satisfactory by EPI, their **bid will be considered non-responsive and rejected.**
- xi. The Applicant is requested to furnish the existing commitments on works under execution along with stipulated period for completion of remaining for each of the work should be furnished **in an affidavit on non-judicial stamp paper of value of Rs. 100/-** duly certified that the particulars furnished are correct as per the Performa in **Annexure –A.**
- xii. It is desirable that the bidder should have valid PF Registration No. In case, the bidders do not have PF Registration No, the same shall be obtained by successful bidder within one month from the date of LOI or before release of First RA Bill.
- xiii. Should have GST Registration No. (Copy of GST Registration certificate to be enclosed).
- xiv. **Instruction for Micro and Small Enterprises:**
 - a) Bidders have to submit confirmation letter whether they are registered under MSME/NSIC Act or not and if yes, then relevant copies of the registration letter in relevant category (Registered under NSIC/MSME, Govt. of India, Ministry of MSME, New Delhi) to be enclosed in Technical Bid and a request letter for claiming exemption from submission of Tender fee and EMD.
 - b) Small scale Industries registered with the National Small Scale Industries Corporation shall be exempted from payment of tender cost/earnest Money Deposit as per eligibility limits.
 - c) The value of free issues material (if any) shall be taken while evaluating completion cost of project. The value of such materials incorporated in the project should be certified by chartered accountant.
 - d) All the bidders have to mention their MSME status. The bidders who are not registered under MSME act they have to submit their declaration letter. And the vendors/contractors registered in MSME are required to submit the document evidence of their social category i.e. (ST/SC/GEN) and gender (i.e. male/Female) along with the tender.
- xv. Any bidder from a country which shares a land border with India will be eligible to bid in any procurement whether of Goods , Servicers (Including Consultancy services and non-consultancy services) or works (including turnkey projects)only if

bidder is registered with the Competent authority i.e. Registration committee constituted by the Department of Promotion of Industry and Internal Trade(DPIIT).

- xvi. Proposal for subcontracting components of the works amounting to more than 10 percent of the Bid price shall not be permitted, except for specialized nature of work in which new emerging engineering methodology is proposed to be used with the prior approval of implementing agency. Use of such new technologies should be indicated while submitting the bid.
 - xvii. The past experience in similar nature of work should be supported by certificate issued by an officer not below the rank of Executive Engineer or equivalent. The relevant work-order of considered similar work should be submitted by applicant.
 - xviii. The applicant should own sufficient construction equipment for the proper and timely execution of the work. The applicant should submit details of same with empanelment application.
 - xix. Prospective applicant may request clarification on the empanelment document within ten days of publication of this Notice for Empanelment. No request for clarification will be considered after that date.

Organizations, Urban Local Body and/or its Undertaking company during last seven years ending last day of the previous month of date of NIT. **Bidder to submit a notarized self-declaration with the bid in respect of the same.**
9. In case of any discrepancy between the downloaded Request for proposal documents from the website and the uploaded copy by the Applicant, the Request for proposal documents appearing in the website being uploaded by EPI with the Request for proposal shall hold good for contractual as well as legal purposes.  - i. All the application received, will be evaluated on the basis of Information and documents provided by the applicant. 10. Disqualification

The applicants may note that they are liable to be disqualified and not considered for the opening of Price Bid if;

- a) Representation in the forms, statements and attachments submitted in the pre-

qualification document are proved to be incorrect, false and misleading.

- b) Record of poor performance during the past 10 years such as abandoning the work, rescinding of contract for which the reasons are attributable to the nonperformance of the contractor, inordinate delay in completion, consistent history of litigation / arbitration awarded against the contractor or any of its constituents or financial failures due to bankruptcy etc. in their ongoing / past projects. The decision of EPI in the matter of disqualification due to poor performance in any project ongoing/completed shall be binding on the Applicants.
 - c) If bidder have submitted incompletely filled in formats without attaching certified supporting documents and credentials to establish their eligibility to participate in the Request for proposal.
 - d) If the applicants attempt to influence any member of the committee. EPI reserves its right to take appropriate action including disqualification of applicant(s) as may be deemed fit and proper by EPI at any time without giving any notice to the contractor in this regard. The decision of EPI in the matter of disqualification shall be final and binding on the Applicants.

12. Bidder has to upload all the relevant certificates regarding PQ criteria for qualifications, with the Request for proposal uploaded documents & hard copy submission (as mentioned in special instructions to bidders) will be considered for qualification.

13. FINAL DECISION MAKING AUTHORITY

EPI reserves the right to extend the date of submission of the Request for proposal or cancel the Request for proposal or accept any Request for proposal or reject any or all Applicants or annul this Request for proposal process or bid acceptance at tender process without assigning any reason and liability whatsoever and to re-invite Request for proposal at its sole discretion.

14. EVALUATION CRITERIA FOR EMPANELMENT

For the purpose of empanelment applicants will be evaluated on the basis of financial and past experience criteria as mention in pre-qualification. The bidder's application is also may be disqualified if:-

- a. Record of poor performance such as abandoning work, not properly completing the contract, delay in completion of works, or financial/ weakness etc.
- b. Made misleading or false representation or deliberately suppressed the information in the forms statements and enclosures required in the pre-qualification documents.

15. EXPERIENCE IN SIMILAR WORKS

Applicant should furnish the following;

- a. **List of all similar works successfully completed during the last five years (in form "D")** Particulars of completed works and performance of the applicant duly authenticated / certified by an officer not below the rank of Executive Engineer or equivalent should be furnished separately for each work completed or in progress (preferably in form "G" or as per, all concerned client covering the required information as ask for in form G)

16. CANCELLATION OF EMPANELMENT

The empanelment of contractor shall be cancelled by EPIL in case of their poor performance, abandoning of the allotted work, and abnormal delay in completion of work, bankruptcy and for activities detrimental to the interest of EPIL the decision of EPIL in this regard shall be final and binding on the contractor.

The contractor / firm shall not affect any change in the constitution of the firm or in its name without the prior approval of EPIL Such proposal, if any shall be submitted in advance furnishing full details of the proposed change along with all supporting documents. Any change in the constitution or name of the firm/ company without the prior approval of EPIL will render the contractor / firm liable for removal from the approved list of contractors. The discretion to allow / disallow the proposed change shall vest solely with EPIL. In case, the original partners / constitution changed by more than 50% either due to substitution or due to retirement or death the enlistment of the firm / contractor by that name shall be cancelled.

17. PARTICIPATION FOR FINANCIAL BID

Empaneled / Qualified Construction agency / firm may be intimated separately through EPIL web site/ e-mail/ speed post for submission of financial bid, additional technical documents (if required any), Earnest money deposit.

Financial proposals of the only those firms who are technically qualified shall be opened online on the date & time specified to be notified.

Information relating to the examination, clarification, evaluation, and comparison of bids and recommendations for the award of a contract shall not be disclosed to bidders or any other persons not officially concerned with such process until the award to the successful Bidder has been announced. Any attempt by a Bidder to influence the Employer's processing of bids or award decisions may result in the rejection of his/her Bid.

In order to maintain confidentiality of assignment, contractor shall not share details of projects including agreement conditions with any agency / organization/individual / other than the clients without prior approval of EPIL.

18. ARBITRATION
