



The Nest Outdoor Gear Shop RENTAL AGREEMENT



EQUIPMENT CHECK-OUT AND RETURN

It is the responsibility of the renter to inspect all items for damage, missing parts, and cleanliness upon item check-out. All returns must be made to The Nest during posted gear shop hours on the date agreed upon during check-out. The Nest is not liable for gear returned outside of gear shop hours and applicable late/lost items fees will be applied. Equipment will be assessed by The Nest staff upon return and any fees will be communicated within 5 days of equipment return.

LATE/ CLEANING / DAMAGE / LOST FEES

Gear will be charged the additional daily rate for every day that it is overdue up the full replacement fee of the overdue item/s. Gear must be returned in the condition in which it was checked-out. Cleaning fees will be assessed for excessively dirty equipment and will be assigned based on the cleaning time required, with a maximum cleaning fee of \$20 per item. Please do not launder sleeping bags or wash tents without first consulting with The Nest. Renter will be assessed fees up to the full replacement price and shipping fees of damaged items based on employee time and cost of materials required for the repair. Renter is responsible for the full replacement cost and shipping fees of any items or parts of items that are lost. Fees will be communicated in writing to renter within 5 days of the return and must be paid within 10 business days. Failure to pay will result in student account holds or charges to account on file.

STUDENT ACCOUNT HOLDS

The Nest has been authorized to place holds on student accounts for any fees that go unpaid longer than 10 days from the issue date. To release a hold on your account, you pay the full balance in-person during shop hours at The Nest.

RELEASE OF CLAIMS

Renter acknowledges that there are no warranties applicable to the equipment rented from the The Nest whether express or implied. The Renter accepts the equipment AS IS at the time of check-out. In addition, The University of Washington – Bothell cannot be held liable for injuries sustained to Renter while using, transporting, or handling rented equipment. It is the responsibility of the Renter to obtain and follow proper instruction on the safe use of any rented equipment. The Renter is responsible for any consequences arising from the use of this equipment. The Renter understands that the use of recreational outdoor rental equipment involves risk, including risk of serious bodily injury, property damage, or even death. In consideration for being able to use The University of Washington – Bothell's Outdoor Wellness equipment, Renter assumes these risks and indemnifies and holds harmless the University, State of Washington, their officers, employees, and agents from any claim, damage, liability, injury, expense, or loss including attorney's fees arising from use of the University of Washington - Bothell recreational equipment, including any claims that Renter's heirs may have in case of Renter's death.

If any of the equipment is dirty, lost, or damaged, I agree to pay the cost of cleaning, repairing or replacing the equipment according to the terms stated above. I have read and understand the contents of this document, voluntarily sign this Outdoor Equipment Rental Agreement, and accept full responsibility for the rental equipment while it is checked out in my name.
