Visitor's Card - Waiver of Liability

The City of Cleveland, Department of Public Utilities is pleased to grant your request to visit its facilities. We shall do our best to make your visit enjoyable and one that you will remember with pleasure. During the visit, please follow all safety instructions of your guide carefully.

I, _____, individually and/or as parent or legal guardian of, a minor, do hereby acknowledge that I am entering the property located at _____ including the buildings located on it ("Property") of my own free will. I acknowledge, understand and accept that the Property is a fully operational water plant and that it contains small and large machinery/equipment that is in full operation in furtherance of the purposes of the facility. I acknowledge, understand and accept that by entering said Property there are inherent risks of property damage and/or bodily injury both foreseen and unseen due to the day to day operations involved in operating a water plant. I voluntarily accept and assume all risks, hazards and possible losses that may occur while I am on the Property. I agree to follow all safety instructions and directions that are posted on the Property or provided to me (whether written or oral) by a representative of the City of Cleveland Division of Water.

I have read and understood the Waiver of Liability and acknowledge, understand and agree to waive, release and discharge the City of Cleveland, Department of Public Utilities Division of Water and all other City of Cleveland departments, and employees or their representatives for any and all property damage, expense or bodily injury that I may suffer while I am on the Property.

Non-Disclosure Agreement

As a condition of being permitted to visit/tour the Property described above, I acknowledge and understand that I may be exposed to security information ("Information"), including but not limited to, security, access points into the Property, physical condition of the Property, the composition of the Property and the configuration of the Property that is owned and operated by the City of Cleveland, Department of Public Utilities.

I acknowledge that the Information that is learned or provided by the tour of the Property is of a sensitive and confidential nature and any unauthorized release of the Information would seriously endanger the security, health and safety of the City of Cleveland's water system and persons using water supplied by the City of Cleveland Division of Water and all of its customers.

The undersigned agrees not to disclose such Information obtained by visiting this Property to other individuals, companies and/or corporations or governments unless required to do so by state or federal law. The undersigned further agrees that for security purposes he/she is not permitted to use electronic devices to take pictures, video or audio during the facility tour. However, professional photos or videos taken by the City of Cleveland, Department of Public Utilities or the Division of Water during your visit may be used for promotional or educational purposes by the City of Cleveland Division of Water.
