GENERAL NOTES:

1. Complete proposals will be reviewed in June and October of each year.
 2. Please include a self-addressed stamped postcard with your proposal submission so that the Committee can acknowledge receipt of your proposal and advise you of the expected review date.
 3. Scheduling of exhibitions will be done at the discretion of the Committee and the PAAM Director. Please note that in most cases exhibitions are scheduled a minimum of eighteen months in advance of the exhibition.
 4. Exhibition curators are responsible for the installation of their exhibitions. With the exception of installations, artists who are the subject of the exhibition may not be present during the installation. Gallery assignments are done at the discretion of the Committee and the PAAM Director.
 5. Commercial Galleries representing the artist(s) subject(s) of an exhibition may not serve in a curatorial capacity for the proposed exhibition. Likewise commercial galleries may not be involved in hanging the exhibition.
- * Please note that ALL proposals must be submitted by the proposed exhibition curator. The curator(s) may not be an artist(s) in the exhibition. Family members of artists in the proposed exhibition will not be considered as exhibition curators.
