1. All consignment must be in good condition. **NO STAINS, HOLES OR MISSING PARTS.** Clothing should be laundered or dry cleaned, **FREE** of **SMOKE** and **PET HAIR**. If items require cleaning, polishing or minor repair, and we choose to accept the item; we reserve the right to charge a fee of \$15.00 for the services. This fee will be deducted from the consigner's account.
2. Sweet Repeat Consignment sets appropriate prices on items based upon a combination of experience, knowledge of market trends, and current resale values. **PROCEEDS ARE SPLIT 50/50.**
3. Items that are dropped off without an appointment and found to have **HOLES, STAINS, BROKEN** or have **MISSING PARTS** will be marked or donated without notification.
4. Sweet Repeat Consignment displays consigned items in our store for a maximum of 90 days. After 30 days, the remaining items are reduced in price by 25%. At 90 days, the items are reduced in price by 75%. If the items have not sold in the allotted 90-day period, they must be **PICKED UP BY THE OWNERS WITHIN 1 WEEK of the contract expiration date. Contract expiration dates (also referred to as item pick-up dates) are listed at the bottom of the contract. IT IS THE RESPONSIBILITY OF THE CONSIGNER TO MONITOR THE EXPIRATION DATE as Sweet Repeat Consignment does not have the resources to guarantee reminder calls.**
5. Items not retrieved after the expiration of their 90-day contract and the passage of the 1 week grace period will become property of Sweet Repeat Consignment and at which time will be donated to local charities of our choice or do what we see fit. (Will not be donated to Goodwill)
6. Any time during the month, Monday through Thursday, you can come into the store and check on the balance of your account. If there is less than \$50.00 in the account we can pay cash that day. If there is more than \$50.00 in the account we will need 24-48 hours to write you a check. **IT IS THE RESPONSIBILITY OF THE CONSIGNER TO CHECK ON THE BALANCE OF THE ACCOUNT.**
7. Sweet Repeat Consignment will take reasonable care of all consigned items and is not liable for the loss, theft, fire or damage to any consigned items. **CONSIGNMENTS LEFT WITH SWEET REPEAT IS AT THE RISK OF THE CONSIGNER.**
8. Sweet Repeat Consignment reserves the right to review the terms of this contract and to make any necessary changes. Sweet Repeat Consignment also reserves the right to terminate this or any contract made with Sweet Repeat without notice.
