**DEFERRED PAYMENT / INSTALLMENT AGREEMENT**

**\*\*After the first missed payment the meter will be locked and payment agreement will be null and void. To reactivate service member must pay balance due in full. If balance is not paid in full within 10 days of lock date meter will be pulled.**

**Installment payment will be in addition to monthly water service bill.**  
**NO PARTIAL PAYMENTS WILL BE ACCEPTED**

Failure to fulfill any term of this Agreement shall institute the Corporation's disconnection procedures as set forth in the Corporation's Tariff.
