

Enchanted Boutique Consignment Agreement

_____ (hereafter referred to as Consignor) is the owner of all goods consigned to Enchanted Boutique (hereafter referred to as Boutique) and has the legal right to enter into this Consignment Agreement; and the goods are saleable and /or free & clear of liens or other claims.

1. Boutique retains the right to accept or decline any item for consignment at their sole discretion and retains the right to display items for sale as they see fit, including online sales. If Consignor is shipping item(s) to the Boutique, acceptance must be obtained prior to shipment by sending photos and descriptions of item(s) to Boutique along with signed Consignment Agreement.
2. Consignors agree to present goods clean, complete and free of defects.
3. The costs for shipping the item(s) to Boutique will be added to the cost of the item(s) unless personally delivered to the Boutique.
4. The Consignment period is for 3 months with periodic markdowns. The Consignment period may be extended with the agreement of both parties for additional terms up to a maximum total time of 1 year.
5. All items are subject to markdowns and coupon specials at any time. You, the Consignor will receive 60% of the price the item is sold at, no sooner than 10 days after the item sells to allow time for checks/charges to clear. Boutique will mail checks to Consignor no more than once per month.
6. The Boutique will price all items at current retail prices using online pricing and lowest advertised prices as our base, the demand for the item and taking into consideration the suggested retail price from the Consignor.
7. It is the responsibility of the Consignor to periodically check your account by either contacting the main telephone number at 612-889-4405 or emailing the Boutique at contact@enchantedboutiquemn.com. Item(s) and/or monies not collected after one year of activity are forfeited to the Boutique and inactive accounts closed.
8. Boutique does not guarantee your items will sell whether expressed or implied.
9. The Boutique shall not be responsible for loss or damage to items consigned due to fire, theft, vandalism, breakage or natural disaster.
10. The Boutique's number one priority is selling your items at the highest possible profit for you. We want to make consigning easy for you – and us – so we can be on the floor selling your items or entering them into our computerized software to sell quicker for you.
