

Style Me Sue Consignment Agreement

Style Me Sue Consignment Boutique (SMS) is excited to work with you as you clear your gently worn clothes and accessories from your closet! Following the guidelines outlined below should allow the process to work smoothly. I am committed to having something for every style and every budget, while selling your items at the best possible price!

Length of Consignment:

The “consignment period” will be 70-days. If items are not sold within the consignment period, the Consignor will have five business days to retrieve unsold items. After that period, all remaining items become property of Style Me Sue Consignment Boutique and may be donated to a local charity. If the Consignor phones or emails a **two-day notice** of when pick-up is to be made, Style Me Sue will make the best effort to pull items from racks for Consignor and have ready for pick-up. However, this is not guaranteed. Consignor may have to retrieve their own items from the racks.

Accepted Items and Condition:

25 items per consignment period per Consignor unless prior arrangements are made.

All Types of Ladies’ Apparel and Accessories with the Following Exceptions:

- Swimwear
- Intimate Apparel of Any Kind
- Socks unless NWT (new with tags)

I will also accept Damascus High School Booster and Damascus Sport Association sports apparel.

Please phone (301-414-7583) for appointment. All consigned merchandise must be delivered to Style Me Sue Consignment Boutique in very good condition (clean, pressed, folded and placed neatly in a box) and “ready to sell”, not in bags! No clothing with stains, odors, tears, missing buttons or broken zippers will be accepted. Any items later found to be unsuitable for sale will be returned to owner or donated. Consignor must disclose at this time any and all flaws or damage.

If an item does not sell at the end of the consigned time, it may show signs of being tried on and handled. Style Me Sue Consignment Boutique is not responsible for cleaning or repairing prior to being returned to consignor.

Authenticity:

Style Me Sue Consignment Boutique accepts only authentic designer items unless clearly marked as faux. Consignor guarantees the authenticity of all merchandise consigned.

Pricing:

- Style Me Sue Consignment Boutique will determine prices based on brand, style, condition, and market demand of merchandise.
- After 30-days, items may be discounted between 20% - 50% depending on seasonal demand and the condition of the item. Some out-of-season and holiday items may be subject to further reductions based on market demand.

Commissions and Fees:

- An *annual* **\$10 processing fee** will be deducted from your first check.
- Consignor (you) receives **40% of the *selling price*** (excluding taxes and fees) of the item and Style Me Sue Consignment Boutique will receive 60%.
- Exclusive Designer Items are kept for the entire appropriate season. The commission on these items is **50% to the Consignor**/50% to Style Me Sue Consignment Boutique. The decision to put these items in this category is at the sole discretion of Style Me Sue.

Payments Will Be Made as Follows:

- Checks may be picked up at the store twice per consigning period, after the initial first 30-days.
- A check can be mailed for a fee of \$2.00.
 - Style Me Sue Consignment Boutique is not responsible for any lost, stolen, or misplaced checks. A \$35.00 stop check fee will be deducted from payment for any requests to reissue a check.
- You may come into the store at anytime during the month to use any Consignor's credit.

Risk of Loss:

Upon delivery and acceptance of all consigned merchandise, Style Me Sue Consignment Boutique will do its best to secure all items. However, in cases of theft and/or damage, Style Me Sue Consignment Boutique will not pay for items that are lost, stolen or damaged.

Record Keeping:

Style Me Sue Consignment Boutique agrees to maintain documentation of all contractual agreements and sale transactions on behalf of the Consignor, but it is ultimately the responsibility of the Consignor to maintain all accurate records of merchandise consignments and contract expiration.

Agreement:

This agreement may not be modified unless agreed to in writing and signed by Style Me Sue Consignment Boutique and the Consignor.
