**Agreement:**

The artist grants Vinyl Revolution a global, non-exclusive, non-transferable and non-assignable use of all images listed above for an indefinite period, to be waived one month after the artist sends a written confirmation for the cancellation of the license, for the purpose of producing and selling vinyl graphics. This includes, but is not limited to, any and all uses of the images for product photos, marketing purposes, websites, social media content and any other digital and physical platform Vinyl Revolution deems necessary to sell the artwork.

**Payment:**

Payment for the images and/or artwork provided by the artist will be made on a commission basis for each unit sold as a vinyl reproduction of the original artwork. The total remuneration will be transferred in full to the artist on the last day of each month via bank transfer in GBP. The artist reserves the right to request receipts from Vinyl Revolution for all sales pertaining to their work in order to verify the total owed to the artist.

The artist shall receive 20% of the final sale price of each vinyl graphic sold (minus shipping costs) based on their artwork if their work is supplied in vector file format that is ready for production. The artist shall receive 15% of the final sale price of each vinyl graphic sold (minus shipping costs) based on their artwork if their work is supplied in image file format that is not ready for production. All digital and physical reproductions of the artwork for editorial and marketing purposes are permitted without remuneration in order to maximise the exposure of the artist and promote the sale of their work in vinyl form.

**Provisions:**

The artist retains all copyright and moral rights attached to this image as well as any other rights which may not be detailed in this agreement.

Credit/Acknowledgement of the artist's name must be given when the image is published, either with a picture credit, caption or a link/acknowledgement in the publication if the image is used for editorial purposes (newspapers, magazines, newsletters, web or print publications, etc...).

Selling of this image by Vinyl Revolution in any form other than the vinyl format agreed upon with the artist is forbidden.

Vinyl Revolution is allowed to crop and/or electronically alter the images to suit their purposes for the usage stated in the agreement. This includes format changes for the purpose of marketing the artist and associated images across all Vinyl Revolution's e-commerce platforms, partner websites as well as any other third party sites or publications intended to increase exposure of the artist.

**Indemnity:**

Vinyl Revolution indemnifies and holds harmless the artist against all claims, liability, damages, costs and expenses stemming from a breach of this agreement, the use of the image, your failure to abide by any restriction regarding the use of an image, or any claim by a third party related to the use of the image.

**Warranty and Liability:**

This image is provided "as is" with no warranty regarding the suitability of the image for any purpose. The artist is not liable to Vinyl Revolution or any person or entity for damages, costs or losses stemming from any usage of this image.
