2022 COMMUNITY CENTER FLOORING REPLACEMENT PROJECT


The City of Saint Peter is currently accepting formal written proposals for a project to replace carpet with hard surface flooring in the Saint Peter Community Center at 600 South Front Street, Saint Peter, MN 56082. The work to be performed includes 3 rooms.

Room 117: Replace missing VCT tile supplied by customer.

Room 119: Removal and disposal of existing carpet and rubber base, prep floor and install LVT/LVP and new base.

Room 125: Cut around carpet to be left. Removal and disposal of existing carpet and rubber base, prep floor and install LVT/LVP and new base. Install new rubber transition from carpet to tile.

WORK TO BE PERFORMED:

Room 117: Replace missing VCT tile supplied by customer.

Room 119: Removal and disposal of existing carpet and rubber base, prep floor and install LVT/LVP and new base.

Room 125: Cut around carpet to be left. Removal and disposal of existing carpet and rubber base, prep floor and install LVT/LVP and new base. Install new rubber transition from carpet to tile.

REQUIREMENTS:

- All old materials must be properly disposed of as per current State and Federal regulations.
- New base should closely match existing base.
- LVT/LVP shall be of high quality with sample provided for color and quality.
