Any Quote in which the Quoter shortens the acceptance period shall be rejected, although the acceptance period may be extended by agreement between VRE and the Quoter. At the end of the Quote acceptance period, the Quoter may withdraw its Quote by giving written notice to VRE.*
9. *A firm-fixed price Blanket Purchase Order will be awarded by VRE to the lowest responsive and responsible Quoter conforming to the requirements of this solicitation on a TOTAL PRICE basis.*
