Contract Amendment for Event Planning & Implementation Services

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Doxtater & Company LLC dba The Workshop to exercise the contract option for Phase II of the scope of work, which includes implementation services for opening events for the University and South 200th Link Extensions, in the amount of \$642,935 for a new total authorized contract amount not to exceed \$710,875.

KEY FEATURES SUMMARY:

- In January 2015, Sound Transit contracted with Doxtater & Company LLC dba The Workshop to perform Phase I of the Event Planning & Implementation Services contract supporting the opening events for the University Link and South 200th Link Extensions.
- Phase I was completed within the CEO’s authority and included work to develop and refine the size and cost estimate for both opening events.
- This action would provide funding to exercise the contract option for Phase II of the contract, which includes detailed planning work for the University and South 200th Link Extension openings, as well as assistance staffing, implementing, and managing each opening event.
- Phase II also includes event-related costs including equipment rental, permitting, entertainment, supplies and staffing which will be managed through this contract. The contractor will receive reimbursement for actual costs expended per the agreed-upon scope.

Phase II is scheduled from September 2015 to December 2016 and the amount requested is sufficient for all Phase II activities.

BACKGROUND

Light rail service extension openings are high-visibility, high-impact events that provide Sound Transit with an opportunity to promote the new service, attract new riders, educate the larger community about the agency’s mission, and celebrate with the host communities who have been affected by Sound Transit construction activities.

Consultant services are being used in planning and implementing these opening events because of their specialized expertise and because of the quantity of experienced individuals that are needed for each event. In addition, there are a significant number of logistical demands that need to be met with qualified sub-consultants and agency coordination of this work would be a significant administrative burden.

In January 2015, Sound Transit issued an RFP for specialized consultant support needed to plan and execute the opening events for the University Link and South 200th Link Extensions in 2016. The agency received five bids and Doxtater & Company, LLC (The Workshop) was selected as part of a competitive process.

The Workshop is a local firm with extensive experience in planning and implementing large special events and festivals, including transit line openings. The contract with The Workshop includes two phases. Phase I included development and refinement of a range of potential event sizes, cost estimates, and configurations for both opening events as well as to facilitate decision-making with agency leadership regarding the scope, size and timing of each event. Total compensation for Phase I of the contract was \$67,940. Phase I spanned from March to August 2015.

The scope of work for Phase II allows the Workshop to continue planning the opening events; hire and manage contract staff, entertainers, and equipment vendors needed for the events; implement the events on each respective opening day; and conduct post-event recap reports and evaluations.

In order to streamline administrative demands and take full advantage of the consultant's skills and experience in event planning and management, event-related costs (e.g. equipment rental, permitting, entertainment, supplies and staffing) will be managed through this contract. The contractor will be reimbursed for actual costs.

FISCAL INFORMATION

Commitments and costs for the proposed contract amendment with Doxtater & Company, LLC dba The Workshop for \$642,935 will be distributed between the University Link and South 200th Link Extensions.

The lifetime budget in the 2015 Transportation Improvement Plan (TIP) for the University Link Extension is \$1.756 billion. The proposed action would commit \$498,599 for Marketing Services and Special Events within the Agency Administration phase. Since no budget has been set aside for this new line item, it will be funded from available uncommitted budget within the Agency Administration phase. Should the proposed action be approved, the Agency Administration phase will have a remaining budget balance of \$38,460,263.

The lifetime budget in the 2015 Transportation Improvement Plan (TIP) for the South 200th Link Extension is \$383.2 million. The proposed action would commit \$144,336 for Marketing Services and Special Events within the Agency Administration phase. Since no budget has been set aside for this new line item, it will be funded from available uncommitted budget within the Agency Administration phase. Should the proposed action be approved, the Agency Administration phase will have a remaining budget balance of \$4,476,561.

This action is within the adopted budget and sufficient monies remain after approval of this action to fund the remaining work in the Agency Administration phases within the University Link and South 200th Link Extensions as contained in the current cost estimates. Use of Agency Administration phase unallocated contingency within either project is not required for this action.
