THIS DEED OF ABANDONMENT AND PARTIAL RELEASE OF DEED OF EASEMENT AND AGREEMENT, made this \_\_\_\_ day of \_\_\_\_\_, 20\_\_, between **Anne Arundel County, Maryland**, a body corporate and politic of the State of Maryland (“County”), Grantor, and \_\_\_\_\_ (“Property Owner”), Grantee;

WHEREAS, the County was given certain rights under a DEED OF EASEMENT AND AGREEMENT in order to create a forest conservation easement, dated \_\_\_\_\_, and recorded among the Land Records of Anne Arundel County, Maryland at Liber \_\_\_\_\_, folio \_\_\_\_\_ (the “Easement”); and

WHEREAS, the Property Owner acquired real property, a part of which is subject to the Easement, by deed dated \_\_\_\_\_, and recorded among the Land Records of Anne Arundel County, Maryland at liber \_\_\_\_\_, folio \_\_\_\_ (the “Property”); and

WHEREAS, § 17-6-307 (b) of the County Code provides that the County may abandon a forest conservation easement subject to certain conditions, and the Planning and Zoning Officer has determined that the conditions precedent to abandonment found in §17-6-307(b) have been satisfied;

NOW THEREFORE, in consideration of the premises and the sum of One Dollar (\$1.00), the receipt whereof is hereby acknowledged, the County abandons, releases, grants, and reconveys to the Property Owner, its successors and assigns, in perpetuity, that part of the Easement described as follows:

All that portion of the “Conservation Property in Areas \_\_\_\_\_ to be Removed” as described on Exhibit A and as depicted on Exhibit B hereto.

Being a part of the Property, as aforesaid.

TO HAVE AND TO HOLD unto the Property Owner, its successors and assigns, all for the purpose and intent that the estate, interest, easements and servitudes created under the Easement are terminated, extinguished, and no longer in force and effect, as to the Property. The terms of the Easement affecting the Property are hereby extinguished and the Easement is abandoned as to the Property.
