In order to be considered for any session, PLTC applications must indicate a first choice and a second choice that is either later or in a different location. Your second choice cannot be earlier than your first choice. Plan to attend either session until you receive an official confirmation of registration into a PLTC session. There is no guarantee that you will be admitted to your first choice, especially for the highly requested Summer PLTC sessions. If you request a Summer session as your first choice, select your second choice wisely.</p> <p>If you are completing PLTC as a law clerk, please note that you may only attend PLTC before or after your clerkship term. You may not select a session which occurs during your clerkship term.</p>
