# ADULT RESIDENCY AFFIDAVIT INSTRUCTIONS

**NOTICE: READ CAREFULLY:** Knowingly falsifying this document is a violation of the Ohio Revised Code: Section 2921.13(A) (6) which is a First Degree Misdemeanor punishable by a prison term of six (6) months and/or a fine up to \$1000.00. Further the affiant will be billed (and prosecuted in court, if necessary) to collect all back tuition which may be due. Inaccurate and/or false information will result in immediate withdrawal of your child(ren) from the Mad River Local School District.

1. The Adult Residency Affidavit must be renewed each school year, and must be filled out ***COMPLETELY***.
2. Parent/Guardian must provide two (2) proofs of residency documents verifying that you live at the address. First proof must be returned with ARA to begin enrollment. The second proof can be returned to school building within 30 days of move. Documentation can consist of two (2) of the following: recently issued drivers license or state id, vehicle registration or insurance, payroll check, child support check, social security/welfare/assistance payment, voter registration and/or income tax documents.)
3. Person you are residing with (Renter or Home Owner) needs to provide 2 proofs of residence documents verifying they are the owner/renter of the property. (One document ***MUST*** be their Lease Agreement, Mortgage Payment Coupon or Deed if they own free & clear. The second can be Electric bill, Gas/Oil bill, Water bill, Home Owner or Renters Insurance.)
4. Have the Affidavit notarized and return form and proof of residency documents to Building Pupil Services Secretary.
5. Adult Residency Affidavit is valid ***ONLY*** for the school year in which it is completed. A new application must be completed and submitted to the school of the youngest sibling with proof of residency prior to the start of each school year.
