- To accept this quote we require a deposit of 40% of the order total with the balance due strictly on the day of installation.

INSTALLATIONS:

- Delivery of your order may vary between 3-5 weeks (8-10 weeks for plantation shutters)
- Campbell and Heeps will endeavour to complete your order in the shortest possible time frame but we will not accept cancellations for delayed orders.
- Timing will depend on the product selected and availability of the fabric you have chosen and upon the workload at the time of order placement.
- Campbell & Heeps will contact you and advise of fabric delays, we cannot be held responsible for delays from fabric suppliers.
- Installation includes hanging of Campbell & Heeps manufactured goods only, all surface preparation and other contractors that may be required will be at the clients' cost and discretion ie. Painting, plastering, cleaning timber beams etc.
- All Electrical work is to be done by others. We are happy to liaise directly with your registered electrical worker with regards to what you require.
- Any hire of access equipment (i.e. Lifting and raising equipment) that may be required will be an additional cost. This will be confirmed with you at the time of check measure by our installers and will be arranged by our office staff.
- Printing and sign writing to be done by others but can be done in our factory prior to installation if necessary.
- We will endeavour to schedule an installation appointment that suits you; however working to specific access times may delay your order completion.
- On the day of installation please ensure your windows are freely accessible by our technicians and you have your final payment ready.
- All goods remain the property of Campbell and Heeps until paid for in full.

WARRANTY:

- Campbell & Heeps warranties all newly manufactured goods and installations for a period of 12 months from installation. Re-clothing and reworking of your existing blinds is subject to the quality of the existing blinds will not be covered by warranty.
- Most fabrics available carry a 5-year warranty, for fabric degradation other than normal weathering, check with your consultant if you are not sure about your selected fabric.
- Motors are covered by a 5-year manufacturers warranty, excluding water damage and faulty wiring. Electrical control devices such as switches and remotes are covered for 12 months.
